W4JVN Dave writes that he enjoys the newsletter and finds it informative and well done and wants to use this means to advise the net members of something that should not be discussed on the air. We all know about the activities of K7/// and WB8///. It has been my policy to call the FCC in Washington, D. C. when these individuals start to do their thing. (I live just outside D. C. so it takes only a few seconds to call the watch officer.) In a recent telephone conversation with the watch officer he advised me to do the following: When these individuals start to CRM the frequency call a local FCC monitoring station to make sure the FCC is listening. Then move the net a few YC's see if the station follows. If he follows move the net frequency again. Do this about three times. If we can get him to follow the net while the FCC is monitoring we have them cold. This is the only way to solve the QRM interference problem. I asked the watch offiver what about moving the net on top of other QSO's and he said not to worry about that. We have to move the net and hope that the person doing the QRM will follow. The watch officer also said it is

VERY IMPORTANT that no one say the FCC is monitoring the frequency as this will scare the person away. What I am saying should not be mentioned over the air. In case some of our net members get disturbed enough to want to call the FCC, the phone number of the Watch Office and Monitoring Station in Washington, D. C. is 202 632-6975. I believe this office is manned 24 hrs a day. I have found someone there on weekends and holidays. I hope that this information is helpful to the net members. If we work together we can get rid of these individuals with the help of the FCC.

Around Thanksgiving and Christmas I hope to be making some mobile trips to Virginia counties that I have requests for. Those that need help in Virginia might send me a list of what they need. One trip will be in the S. E. Virginia area near Lancaster county and another will be in the N. W. counties like Page, Green, Shenandoah, Orange etc. Day of trips will be announced on the net. I hope to get counties that WA5OCG, W6JHV and WAØLRQ need. So if people let me know what they need, I'll try to do what I can.

I just think it is a wonderful group of people we have on the ICHN. I am real happy to be associated with them.
