MINUTES OF APRIL MARAC MEETING

The regular meeting of MARAC, Inc. was held April 3, 1971, at the QTH of WAØSHE at 8 PM. Members present were: WAØWOB, WØAYL, WØYLN, WBØCYD, K8DCR, WAØSLG and WAØSHE. The minutes of the March meeting were adopted as presented in the last newsletter. WØAYL, Treasurer, reported a balance on hand of \$245.47. WAØWOB asked for action on the proposed notice of amendment to the By-Laws as presented to members in the March newsletter. Motion to accept the amendment was made by WAØWOB, seconded by WØAYL. Motion passed unanimously. WAØWOB asked WØYLN to comment on progress with newsletter format change. Clyde Will pursue his efforts to obtain the help he need in the Leavenworth area if possible. K8DCR asked if Air Mobile or Maritime Mobile contacts would count for MARAC DX AWARD. Rules governing this award were set from DXCC rules. however, further discussion on this when $W\emptyset SJE$ is again available. The format for the ballots for Net Control and Mobile Operator for 1971 was discussed. WAØSHE will send format to be included in April newsletter. Deadline for return of ballots is June 1, 1971. Counting of ballots will be the same as last year. Meeting adjourned at 10:30 PM. The May meeting will be held May 1. at the QTH of WAGWOB. MARAC will be honored at this meeting with guests ZL1KG and his XYL.

Note..Our policy is that all stations receiving the newsletter out of the U.S. would receive their N/L by air mail due to the time involved in surface mail). I have sent off to Ed W2GT an application for USA-CA 500 for my brother GC3GMH - he now has 512 confirmed. I have now 345 to get. G3DO I enjoy receiving the MARAC Newsletter each month, and I get on the net as often as possible subject to conditions on the air of course. A jamming station comes up on 14.336 sometimes and this makes it almost impossible to copy the mobiles, however generally I receive the mobile stations very well and in fact I joined the county hunters net when it first opened but was not very active during 1969 and 1970 because I spent my time trying to obtain 5 band DXCC. My counties confirmed are now 2050, so still have a long way to obtain all the counties available. I find the mobiles and net control stations very courteous and helpful to the DX stations, but it is rather difficult at times to pick up call signs (unless they are spelled out) and also names of counties, as in many cases we are not conversant with the names. I think the DX stations have a much harder time in collecting counties and we appreciate the help given by other members on the net- particularly those net controls who spell out call signs and counties.

WHARH/IIDFA Thought I'd better drop you a few lines of information and have you pass it along to MARAC and ICHN via the newsletter. I know some of the fellows are wondering what has happened to the cards they have been sending me and I'd like to reassure them that they shall be returned as soon as possible. I departed Barksdale AFB, La. on 5 Feb, and operated mobile through Louisana, Mississippi and Alabama. I ran a few counties in Georgia between 5 Feb and 14 Feb, then proceeded, minus mobile rig to New York and subsequently to my new duty station at Naples, Italy. All logs for operations before 5 Feb are in my household goods, somewhere between Louisiana and Naples! As soon as they arrive, I'll ship out all outstanding cards as quickly as possible. All cards for operation after 5 Feb 71 are being returned as they come in, since I have brought those logs with me in my baggage. I've been monitoring the ICH net on spare receivers here at the station, and most of the signals are surprisingly good. W4BPC/M is a lot stronger here in Italy than he was in Louisiana!! I'm lucky enough to be stationed near (20 miles) one of the five stations in Italy that can be operated by U. S. Military personnel. I'll be checking into the net as time permits, trying to pick up the 600 or so counties I still need. The station call is IIDFA, but any cards for county-hunting operations should be sent to my duty address as given below. This will be my address for the next three or four years, so you might change the newsletter mailing list accordingly. 73's Norm.

MARAC NET CONTROL AND MOBILE OPERATOR OF THE YEAR

In accordance with provisions in MARAC Constitution, "to recognize and award outstanding accomplishments in Amateur Radio with emphasis on mobile operations", MARAC members are being given this opportunity to select their choices for MARAC Net Control of the year and MARAC Mobile operator of the year (70-71). A plaque will be presented at the MARAC meeting KC-71. Deadline for returning your ballot will be June 1, 1971. WE ASK THAT THE SELECTING BE HELD IN CONFIDENCE AND NOT DISCUSSED ON THE AIR. The winners need not be present or a member of MARAC. Our rules state that the Net Control award may be won by the same station more than once. The Mobile Operator Award may be won only once. Since K7WQJ won the Mobile Operator Award last year he will not be eligible for this award again. K5RPC was the winner for the Net Control Award last year. In making your selections here are a few suggestions as a guideline. THIS IS NOT A POPULARITY CONTEST - PLEASE GIVE IT SOME SERIOUS THOUGHT AND VOTE FOR THE MOST DESERVING PERSON.

NET CONTROL

- 1. Does he hold control of the net?
- 2. Does he keep "his cool' on the air?
- 3. Does he recognize and arrange for all check-ins promptly?
- 4. Does he use a minimum amount of conversations?
- 5. Does he use courteous speech?
- 6. Does he remain impartial?
- 7. Does he comply with FCC rules?

MOBILE OPERATOR

- 1. Does he keep "his cool"?
- 2. Does he use good operating procedure?
- 3. Does he have good signal?
- 4. Does he adjust to net conditions?
- 5. Does he return mobile reply cards?
- 6. Does he comply with FCC rules?

The following has been put together from many sources and is offered as a possible aid to fixed station operation.

FIXED STATION OPERATION

Checking into net.

It is not necessary for fixed stations to officially check in with net control.

A few minutes of listening will give one an idea how net operates. The Independent
County Hunters net usually starts early with a warm-up session between fixed stations
on 14336 between 1200 and 1500 CMT. As soon as mobiles start checking in, the warmup session automatically ceases and someone assumes net control. Due to work schedules
and time difference across country there are no regular assigned net controls. When
net control has to leave, he or she will ask for someone to take over net. If there
are no takers net will be left in open session until someone does take over. Do not
hesitate to offer assistance when net control has to relinquish control. Net cannot
operate efficiently without control. Night time nets operate at 3930 - day time net
72 - -.

Contacting mobiles.

When mobile QRZ's his county he will ask for mobiles and DX stations first, making list of ones heard and exchanging reports as they were heard. When mobile does not copy any more, he will ask for assistance of net control. Do not jump in and attempt any relays of mobile and DX stations until net control asks for any one with additional relays. As soon as all mobiles and DX have been worked, mobile will then call for any fixed stations desiring county or counties. Call the mobile by merely stating your call letters once phonetically. Mobile will make list of those heard and work them in rotation as heard. Mobile will then make another QRZ and new list. And soon, until he is unable to copy with ease, mobile will then ask for assistance from net control on weak stations. When net control has relayed all calls he may hear, the net will be queried if anyone has any relays. - Remember once control has been established abide by controls decision. If you don't like controls decision, then by all means, assume net control sometime when you have an opportunity to do so. Above all -don't attempt relays at any time until asked to do so by net control.

Any station working another for confirmation of a contact regardless of circumstances must fill out a reply card, self-addressed and with sufficient postage for return. These cards are available from WA2AMM and others. Some stations use postal cards and a rubber stamp. If this is not done, don't expect confirmation from the station you worked.

Do not under any circumstances make nasty remarks to any one creating interference to net. You will only lower yourself to the level of the disturbing station. Be courteous Ladies and Gentlemen and enjoy your hobby.
