It is our sad duty to report one of the Charter members of MARAC, WASSOF is now a silent key.

I received the following from W6JHV and pass it along to those who may profit by it. There are three amateurs located in Kalawao county Hawaii, KH6DFN, KH6TS and KH6UG. Anyone who worked KH6GLU/KH6 on Field day in 1969 worked Kalawao county. John is now located at his callbook address.

There is another QSL service for the county hunters in operation now called the QSL CLEARING HOUSE FOR COUNTY HUNTERS. Briefly it operates like this: The county hunter sends \$1.00, four self-addressed stamped envelopes, and as many mobile reply cards that will make up the one ounce limit (or two ounces if he has enough cards). The county hunter then sends lots of mobile reply cards (in one - or two - ounce envelopes) until he receives back the four stamped envelopes, each containing one ounce of cards. The Clearing House will forward cards to the mobiler, along with a return envelope addressed to the Clearing House—again, using the full limit of weight. Using the weight of the cards and envelopes in our stock, we came up with the following sample one—ounce weights:

Average cost less than 2¢ per card. You can also send your personal QSL in case the mobiler needs your county at 2¢ per card. Please accept that the clearing house cannot guarantee that every card will be returned. However, personal experience shows that mobilers are the best QSL-ing hams that ever graced the air-waves. The Clearing House will check the cards returned by the mobileer, but only for signature. The Clearing House cannot be responsible for correctness of the information being shown on the cards. SSB COUNTY HUNTER'S CONTEST Sponsored by the Mobile Amateur Radio Awards Club

The object of this test is to work as many stations in as many U. S. counties as possible.

2200 GMT, Friday, April 7th to 0500 GMT, Monday, April 10th.

RECOMMENDED FREQUENCIES: 3.925/3.975; 7.250/7.275; 14:275/14.300; 21.350/21.375; 28.575/28.600.

CREDITS: No credit will be allowed for contacts on the 14.336, 14.340 and 3.943 nets.

A station is to be worked only once per band in each county. Mobiles and portables can be worked again from different counties. Portables will be considered "fixed" for scoring purposes.

A station may enter both fixed and mobile categories of the test. The exchange consists of: a signal report, consecutive QSO number, county and state (country for DX stations). Copy of the signal report and QSO number is necessary for contest credit. Mixed mode contacts are permissable.

SCORING: Each complete contact with a fixed station - 1 point. Each complete contact with a mobile station - 2 points.

The multiplier will be the number of U. S. counties worked plus the number of countries worked (per DXCC list). Total points x the multiplier determines the final score.

Contacts with stations on a county line count for one contact, but two or more multipliers.

LOG DATA: Date and time in GMT, the complete report exchanged, frequency, and points claimed. Each new multiplier is to be numbered consecutively.

CHECK LISTS: Required for logs with over 200 QSOs and/or over 100 multipliers. Counties to be grouped by states for check purposes; countries to be listed by prefix. SASE to K10ME for info.

CERTIFICATES: Special plaques to the highes scoring fixed, mobile, and DX station. Certificates to the top three fixed and mobile operators in each U. S. call area, and to top scoring fixed stations in each VE call area and DX country. Fixed multi-op and other certificates to be awarded as merited. List of winners to appear in CQ magazine.
