

#### MINUTES REGULAR JANUARY MEETING

The regular January meeting of MARAC was held at the QTH of KWAYO, 1/6/73 Members present were KOYGP, WAOZCQ, WAOYJL, WAOKQQ, WOSJE, WAOWOB, KOBXF, KOPFV, WOAYL, WADSHE & KDAYO. Meeting called to order by WADDOB. Minutes of last meeting adopted as were published in last news-letter. Treasurer reported balance on hand of \$343.75 as of 1/5/73. Secretary reported expenses of \$7.42 for the month. WØSJE reported news-letter info was coming in OK. Several DX stations reported they appreciate receiving the news-letter via Air Mail. WB4FBS (via letter) proposed a new award. It was decided to refer same to the awards committee for consideration and a later report. W6CCM (via letter) proposed a new award basically dealing with recognition of Net Controls. Discussion followed. The existing Merit Award may be a partial solution to proposed award. It was decided to refer this to the awards committee for consideration and a later report. Club station WBØDPD reported expenses of \$7.58 with 1802 Counties confirmed plus 159 worked for a total of 1960 as of 1/6/73. It was decided that the first contact QSL from WBØDPD to non-members would go direct along with MARAC information sheets. WØSJE reported a window sticker decal will soon be available. This decal is 3 x 5 1/4 inches and will cost members 60 cents each or 2 for \$1.00. The decal is in color. KØAYO will handle all applications. The decal should be available within two weeks. Discussion as to an electric typewriter was held. The best deal to date was \$350.00 for a reconditioned and guranteed machine. It was decided to postpone a decision until after the treasury is more solvent following renewal of dues in April. The following assignment for meetings were made, KOPFV for February, WAGYJL, for March, Central Illinois (probably Effingham) for April, WDAYL for May, WADSHE for June & Ft. Wayne Indiana Convention site for July. The Secretary reported he has cut-out slips, advertising MARAC available for sending with mailings to non-members. They are available free of charge, send requests to KWAYO. MARAC will undertake the updating of the County Hunters History, with the assistance of WB4FBS and present same during the ICHN Annual Meeting in Ft. Wayne Indiana. Meeting adjourned at 2120. Suspend Article 7 Section 4 of by-laws from period 10/1/72 - 4/1/73. Discussion of mail ballots for Annual election for Officers. Directors agree to idea. WØSJE, WAØWOB & KØAYO will work out details. Meeting adjourned at 1740.





## FROM THE SECRETARY

The following items covering various changes in FCC rules were recently forwarded to ARRL Official Observers. As you read these, remember that in some cases they are opinions, since they require interpretations. At any rate, they are interesting reading. Docket 18803, This is the so-called "Repeater Docket", but there is a great deal of "rider" material in it having nothing specific to do with repeaters. Here is a list - (1) Which call to sign. We go back to the old system of always signing the call licensed to a particular location, if any. Requirements of the owner's permission to operate his equipment is understood, but if you do so you sign his call, sign... your name in his log. Same thing if you are operating from his car. You use your call only when operating your own station or your own equipment mobile or at another location. (2) Unlicensed participation, Any person may participate in amateur communication by any mode (presumably CW) only provided a control operator (not necessarily the licensee) is present to monitor and supervise the operation. This is a significant liberalization. (3) The requirement for notification of FCC in mobile and portable operation is being relaxed. (4) There are some changes in logging procedures and requirements, mostly aimed at simplification. (5) Business Communications are now specifically prohibited by a change in definition of Amateur Radiocommunication. The above is a brief resume to call these changes to your attention. Full details are in October, 1972 QST, starting page 100. DOCKET 19245. This is the one that is going to cause the most headaches because it will require some interpretation. The new Rule 97.114 presumably added for the sake of clarification imposes on all traffic handlers the need for making instant interpretations as to whether the third party traffic we are handling or about to handle is legal or illegal. And, thanks to the new rule, there are many gray areas which, if we had adhered to previous FCC interpretations. would not and did not exist. New 97.114 prohibits "transmission or delivery" of any third party traffic involving material compensation to anyone. It also prohibits any "business communications except for emergency communications (as defined in 97.3) and defines business communications as "any transmission or communication the purpose of which is to facilitate the regular business or commercial affairs of any party. It is also significant that "third party traffic" is not just written messages. It is any communication by or in behalf of anybody but the two control operators. We don't know just how FCC intends to enforce this rule (if at all) but at the moment it looks as though every traffic handler from now on (i.e. after Dec 1) is going to have to read the text of each message he handles and make a determination of whether or not it's business. Since this is hard to do without first receiving it, he either takes the senders word for it or allows the sending station to transmit it conditionally to his (the receiving operator's) interpretation of whether or not it constitutes "Business". If this is what is involved, it sure throws a large monkey wrench into our amateur traffic handling. IS THE FREQUENCY CLEAR? Sometimes a real dogfight can erupt on the band when two stations inadvertently QRM each other and each feels the other did it deliberately? Who has the right to the frequency? Who was there first? Usually this is hard to determine, and in any event there is no future to QRM fights on the Amateur bands. You never know when you are going to cause QRM and often can't prevent it, FCC interpretations in the past to the contrary notwithstanding. QRM is not illegal. Only willful (deliberate or intentional) or malicious (done with malice aforethought) QRM is illegal. There can even be some question that knowing you are causing QRM makes it illegal. No-where do the regulations require you to ask if the frequency is clear before you transmit. If you fail to do so and inadvertently cause QRM, is this illegal. No, it is neither willful nor malicious. If someone thus inadvertently causes QRM, and you keep on transmitting, then you know you are causing him QRM, too, Are you then illegal? No, too big a gray area. Only if the QRM is admittedly or very obviously (not just apparent) being done for the purpose of causing QRM, is it citable. (Cont')

#### FROM THE SECRETARY CONT'

(This next item, while it was meant mainly for 00'S, sure may be the reason you did not get that rare County confirmed). MAKE SURE OF IDENTIFICATION. A great many of the Amateurs, especially on voice, slur their identification. Mostly this is unintentional, because people just don't know how to talk and amateurs are no exception, but unintelligible identification is tatamount to no identification at all and is just as illegal. Don't forget, on voice S sounds like an F (and vice versa), M and N are indistinguishable, A & J sound very much alike, as do Q & U, and there are 9 letters having an E sound(B, C, D, E, G, P, T, & Z). So don't settle for voice identification without phonetics unless you are absolutely sure. I hope this information is a help. de BOB

I have been an active member mobiler on the County Hunters Net since before they organized as ICHN. I recall many wonderful contacts and many experiences. I also miss the calls of many of the old-timers who are no longer checking into the net, for one reason or another. My sole purpose in writing was to express my thanks to Bill, WAINPM for his kindness in arranging for a MARAC "Last County Award" in the State Award program, to be sent to me. My figures are not too easy to come by, but I can identify 37 other such instances and this is the FIRST time I have received such recognition by a fellow County Hunter... This may seem insignificant on some standards but to me it was a fine Christmas present and I appreciate Bill's gesture. I have always taken pleasure in making every effort to get a County needed by one of the County Hunters, if it was at all possible to do so. I consider this part of the game. My hope for all ICH'ERS is that they have a successful County Hunting Year in 1973. 73 to one and all de SPARKY.

W6CCM - Over the past few months, the Bureau has received quite a few envelopes which looked like they had been run through a paper shredder, One came in completely destroyed and contained only one SASE. Another had one QSL card and two dollars in cash. This morning I got a shipment of cards stapled together with a note attached "Found loose in Portland Mails" or words to that effect. This batch of cards was ev evidently returned to the mobiler sincee he had the good sense to stamp his return address on the card. So, I got the idea that if all you fixed stations/mobilers who ar are chasing counties and using the Bureau's services, would stamp your name and address on the front side of the card, just like you used to do, if the cards did get seperated from the Bureau's envelope, maybe the Postoffice would then forward them to you. Sure, it might cost an extra 6 cents but I know I for one would not mind paying rather than lose a county. Our Bureau, an independent effort, continues to grow with each incoming mailing. We shall continue to work for you in tracking down mobilers even when you get the wrong calls on the cards. We had 500 slips printed which we attach when we feel there might have been a boo-boo. Sometimes you have call letters transposed or mistake an S for an F or a N for an M etc. Since we do get on the 20 meter net, we can correct and forward to the right station. We ask again that you bear with us and don't panic when you don't get cards back the duy after you send them. Some mobiles don't get home as much as they would like and they cannot send cards back as soon as possible. We find the turnabout time in most cases to be 7 to 10 days, which is pretty darn good. We again ask the members who go mobile to allow us to use their SASE to move cards along. We do issue credit slips and we invite you to use our SASE also. Don't forget to send in any changes of address you pick up along the way. We have been pretty lucky so far but there are a few we cannot locate at this time. As soon as we get the new Call Book, we will try to clean out the "Duds". 73' de DAVE

Not necessary if you have a good Atlas. (3) Call Book (not necessary if you use either Mobile QSL Bureau or Mobile Clearing House). (4) U. S. Atlas, I prefer the one by Grossett which isn't too big but does have all the Counties outlined. Qnother good one is The Rand McNally which is a little larger and not quite as easy for me to use. I recently saw a nice Atlas put out by the Texaco Oil Company. Any Oil Company also might have and be able to help you out with State Maps. Some have the Counties outlined and some don't, so you will have to do some checking. (5) A large map of the U.S.A. with County outlines. I got one from WA3JFK, Bill Runsner, P.O. Rox 123, Glenshaw Pa. 15116. I see by the last N/L that the U.S. Government Printing Office has one for 25 cents. Mine was \$1.00 and to me was well worth it. Hi. (6) Mobile reply cards, a available from various sources. News-letter ran a complete listing a few months ago, or you can roll your own. (7) Rubber Stamp with your call, name, address, city state, county and zip code. These are available from many sources. Personal QSL Cards for your first contacts. (9) GMT Clock or at least a clock set up on GMT Time. (10) Lots of time and lots of guts and lots of ability to be able to copy through the CRUD that seems to build up on the 20 meter net. 73' de DAVE.
