### W6CCM/Mobile OSL Bureau

To our many good friends, Happy New Year and may 1980 bring you all the counties you need. Looking back on 1979, we'd like to first thank those who assisted us with address info, new calls, etc. Without this help our job would really be rough. To all you mobilers who sign cards the day rec'd our deepest appreciation. 1979 saw quite a few achieve USA-CA numbers and in many cases we have been advised that without the Bureau's efforts this goal would not have been possible. We are very happy that we were able to do the job for you. Our aim from the very beginning was to get at least a 95% return rate on mobile reply cards, including misread calls and one timers. We have been told by some of you that a return rate of 98% has been attained. The Bureau was created in 1971 because of a need for such an operation. At about the time we were formulating operating rules, rates, etc., our good friend Bob, WARAEA was working on the creation of the Mobile Clearing House and the CW CHN already had a Sureau in operation for CW Net contacts. Over the years we have had a high degree of cooperation with all Bureaus. Now we look to the future. As long as there is a need and as long as Miss Barbara is willing and able to do the hard work of addressing the envelopes we shall continue to operate. We must insist that you put your OSL info on the flip side of your MRC's. It makes it very easy if you have this, as Barbara can address your envelope without having to check our extensive 3 by 5 file. Be advised also that if you wish, you may send in a supply of SAE (Self Addressed Envelopes) and if you are really "flush" SASE (Self Addressed Stamped Envelopes). These save time and will give you better returns. We'd like to propose consideration of annual dues to help your Bureau with it's many projects. 1. We do sponsor several county hunters who cannot really aff ord the postage and whatnot. 2. We when required will call anyone needing a county long distance, not collect, no one ringers and thankfully the stations we do call do usually send in an extra green stamp. Our plan would be to acquire a basic home computer and program it with all the necessary information on county givers, county hunters, "hot" counties. etc. and make this info available to all who subscribe. We have had some of our net controls send us copies of their Net Control logs and it has saved some of you missed counties. We would reestablish publication of the Roadrunner on a bi-weekly basis. This would be an adjunct to the MARAC Newlstter and should in no way conflict with the Newsletter as we know it. We'd print trips planned, counties needed, a "Ton Fifty" list and whatever else might be of interest to the members. To clarify our thoughts, we'd have three types of members instead of the two as we have at present. We'd add "Sustaining member" and issue certificate of membership. What we are thinking of is a first year or first time dues of \$5.00 per year and then either \$3 or \$4 for each year thereafter. seem like we are asking for a lot but if you consider the results of such a program, the cost is negligable. Regardless of how you feel on dues. we shall continue to operate as before. Thanks again all your help and we look forward to a good long association.

We ask that you communicate your feelings on this proposal to us ASAP so we can decide just what we will do in the future.

#### Dear Sir:

The following is a sketch as to my Amateur endeavor through the years - WØBHC WØRF, Loren M. Tate

Early in life it was my goal to get on the air and send out that hair curling, nerve tingling "CQ" to the most remote corner of the world.

After my education was completed, marriage and two children acquired, I started out afresh to achieve my lifelong goal.

In 1947 I recieved my first call, wØBHC(Bald Headed Charlie) and got on the air. I had attended night classes in code and theory and passed that dreaded test for conditional license. My rig? A war surplus that had been wired and rehashed over and over again!

In the year 1947 I joined the Southwest Missouri Amateur Radio club. In 1951 they elected me as president of the club-Our active club sponsored Missouri House Bill # 242 for the issuing of amateur license plates. To our delight and amazement the bill passed both Houses without a dissenting vote!

In 1952 I upgraded my license to Class A and also acquired a new rig. With a Johnson Viking 2 setup I really kept the airlanes sizzling with DX and also stateside contacts.

Many experiences have come my way through the years - many times I have been called home from work with the Frisco Hailroad to help hunt for a lost child or to transmit messages due to the heavy ice storms that played havoc with the telephone lines. I have rerouted trains, relayed weather conditions when ice storms disrupted their normal way to travel. As I mentioned earlier there is no greater pleasure than to see a lost child returned safely to its parents. I have had the distinct pleasure of being co-ordinator and assistant co-ordinator of the Greene County Storm Net. More than once have loaded the travel trailer, wire and correc pot and have been sent by the Red Cross to some tornado damaged town where I would set up a emergency network. I have recieved many awards which I have accepted humbly, yet prized highly and they all embellish the walls or my ham shack.

I am now a custodian and trustee of Amateur station wBØSVB set up on the campus of Baptist Bible College, where until recently college credits were given for our classes there.

I have been active both in Army and Air Force MAKS program until illness limited my participation.

My wife and I for many years held our "own" Field Days. We selected different sites - Missouri, Wyoming, W. Virginia, N. Carolina, VE7 British Colombia and On Alaska Highway milepost 953! We both enjoyed each contact far more than the score accumilated. On some of the Field Days sites we shot our dipole antenna over the tree tops with bow and arrow and the insulators used were plastic hair curlers! On one Field Day we had a Classic 33 atop our 23 foot trailer Needles to say many knocked at our door to see if we "were for real"

In April, 1976 we both came down with an incurable disease - County Hunting: On this particular day we left for an extended tour of Alaskatowing our faithful trailer. I had just purchased a new Kenwood 520 that worked like a charm(and stil does). With voice squeaky, palms sweaty and knees knocking out a feeble Morse code I gave out my first county - wow - 6 contacts, what a pileup! This was surely the thing that I had dreamed about as a youth and now it had became a reality! Right then and there we both knew we had been bitten hard by that County Hunting byg.

Conditions were so bad through the klondike, Yukon all over Alaska that we could hardly wait until we could get back to the "lower 40" and get on the air again! On this trip we racked up 15, 25% miles and truly a County Hunters dream. With my wife urging me to travel that extra miles to give someone that special rare county, we seldom traveled interstate but country roads and byways - canyons, mountain tips and narrow tunnels the trailer humbly bringing up the rear!

On our return home my new two letter call WØRP(Roly Poly) was awaiting me and I have enjoyed using it.

I have just finished my last county # 3, 075! This was in Missouri and given me by wBØMIX, Jim Roberts. Now the award and all the seals hang on my wall with wBØMIX's picture parked astride that last county line hangs just below it!

I have been very ill since July 12 and many county hunters have driven far out of their way to give me my last few counties. WB9KCY, Dorothy, WDØEWO Harry and others have monitered and listened for the counties that I needed to finish. I truly appreciate and thank each one for all their help, I couldn't have made them all without their help.

It was also a great joy and pleasure to attend the Atlanta Convention and meet so many of the County Hunters that I had met on the net the past 3 years. They are truly a great group of people!

As you know when I returned home from the convention I went into the hospital and had a section of my colon removed with cancer and it spread to my liver, I am now taking chemotherapy for this. I am still very weak. I am hoping that I can get bakk on the air and give out many more counties to add to the over 700 that I have given prior to my illness.

### HOW "PURE" SHOULD WE BE?

In the MARAC Newsletter (October 79), W5LXG (Steve) expressed his concern that mobile units professing to run county lines at rivers and streams were probably in error...that the county lines at those locations were not contiguous...and that the mobile unit should state which side of the river he was on to satisfy the "purists" among the ICHN contingent. In some respects, I agree with Steve, but I'm not sure that we avid and "purist" county hunters realize that rivers and streams are not the only locations where identification of the county lines may be in error...so much so that I wonder if we really want to be "99.44".

I was most interested in the letter from the Texas Department of Highways. First, I discovered that the great State of Texas had given up its claim to a portion of the navigable river called the "Red River". Someone must have decided that a river two miles wide and one-inch deep at flood-level wasn't very useful. Or, could it be that the State of Texas was deprived of its claim to "old Big Red" at its center channel as retaliation for joining the Confederacy and as a condition to its readmission to the Union in 1870. Someone goofed on the Sabine River, since it was also a part of the Louisiana Purchase, Louisiana should have had the advantage of gaining sole control by having the boundary set on the west side of the Sabine River. I suppose suffering the loss of "old Big Red" was considered sufficient penalty!

Secondly, the letter was baffling, confusing and a blow to my pride causing me to succumb to a few well-chosen words in that part of the letter which states, "The county line markers are usually accurate but due to the lack of good information concerning county lines the exact location is difficult to determine." After regaining my usually sweet disposition, I was still a bit discomfitted by the fact that a representative of an agency of the great State of Texas should have the unmitigated gall to admit that it lacked "good information concerning county lines". To be entirely fair, I had to admit that it could be a laborious task digging three or four feet into the middle of Interstate 10 to find a corner marker. Also, having used a Rand-Mc Nally Road Atlas for several years, I realized that the little gray line on my maps was 1/16-inch wide--on a scale of one-inch to 30 miles (the scale of my Texas R-M map) that represents almost a two-mile width. Now.... I know that the county line is not two miles wide, but that presents a dilemma -- where the @\*!+!! is the Brazos/Washington county line on Farm to Market Road #158 where the only signs are the directionals to the gin! dahling, not that stuff in a bottle...those things that remove seeds from cotton!! Again... I was beginning to get a little puffy around the neck and the temperature arose around the top of my pate because one boundary of my little claim to Texas is the Brazos/Grimes county line...a wet county line. I could just

see some wheel from the Texas Department of Highways appearing at my door with a notice to evacuate because it had been decided that a highway was going to be built on the county line and the best estimate was that it would run through the center of my hamshack. No doubt the first bulldozer would appear and shove me under the rubble just as I keyed my mike to work my last county for USA-CA.

After regaining my composure for the 3075th time, or was it the 3079th, all of Ford's "better idea" light burst and search started for an old, but timely reference, a surveying textbook. A copy of the deed to my property also just happened to appear out of the myriad papers that I had discovered in my search. With book and deed in hand, I sought to interpret what those fellows were talking about. I must admit that I started with a preconceived notion that what those Texas Department of Highway sheels had said was, "we set those signs close enough to the county line that we can get road maintenance from certain crews and the state highway patrol can determine which JP gets to slap that felon with a traffic fine."

Having gotten all worked-up and prepared to prove that a county line was as easy to identify as your mother-in-law, I immediately was deflated. My dead says, in part, "thence, up the Navasota River with its meanders to the place of beginning." Now right there at the meanders, I began to see what those fellows were talking about! I knew what it meant to meander, in fact, I knew a man who bent his elbow now and then who could meander a total of five miles in a long city block. By the time I read all of the information on meanders, and the other considerations that it inspired, such as, "thread of stream", "alluvium", "reliction", "accretion", and "witness marker", I was about to send that text to the shredder. However, the term "witness marker" had a nice tone, so...again...I turned to the text. That lead to a long dissertation pertaining to marking corners and using witness markers in the fence lines to witness the location of a true In short, it conveyed the information that those signs we see in the fence lines and along the roadways may be witnesses to the true markers and miss the purity factor by several hundred feet.

How pure do we really want to be? As a mobile operator, I don't want to do the spade work for the highway department... I'll just be satisfied to run single counties because the purity factor is no better on "dry" lines than on the "wet" ones. While you guys and dolls mull that over, I think that I will take my little mobile rig to the meanders of the Navasota River, my county line, take a big catfish out of the thread of the river, attach him to a stainless steel line and let him serve as the gound for my rig as he swims from embankment to embankment.

A SHORT "COUNTY HUNTERS" QUIZ" de K5MJD

We all know that Alaska is the largest state, and with only four counties would have the largest average county area. N4AIG/3--A Thanksgiving day conversation during a bbrak in net activity has changed my county hunting procedures. Several stations who devote considerable time as both mobiles and net control, with excellent signals either way, informed me of their preference for conducting the net without relays, The two suggestions I received were to (1) improve my antenna system, and (2) change my operating procedures. These suggestions were given ( and taken) as constructive criticism. Subsequent comments from other very active stations indicate they also feel the same way about relays. Because my antenna system ( a dipole at 10 feet) can not be improved at this time, I have taken the latter suggestion and no longer use relays. Ihave less than 700 counties confirmed so the net still offers lots of opportunities to work the mobiles direct. This letter is directed primarily at the net control stations. I appreciate your offers for relay when given, but, for now, choose to do without. This may change when and if, I ever near completion but I'll do it this way for now. Perhaps if so manh of the very active stations feel relaying the weaker stations in while net control or working the relays while mobile is a waste of their time they should so state and stop doing it. # 1980 FLORIDA QSO PARTY

### 1500 UTC Saturday 17 May to 2359 UTC Sunday 18 May

This is the fifteenth annual Florida QSO Party, sponsored by FLORIDA SKIP. All amateurs worldwide are eligible and invited to participate.

CONDITIONS OF ENTRY: Each entrant agrees to be bound by the provisions of this announcement, the regulations of the applicable licensing authority, and the decisions of the Florida Skip Contest Committee, which are final.

VALID CONTACTS: All amateur bands may be used. ALL stations will SEPARATE PHONE and CW logs. A station may be worked once on each band on each mode. Neither crossband nor crossmode contacts (phone to cw or vice versa) will count for contest credit. Florida stations may work other Florida stations, but for contest points only. Out-of-state stations may not work each other for contest credit. Contacts made on repeaters do not count for credit.

ENTRY CLASSSES: Florida stations will be divided into two classes. Class "A" stations are those operating portable or mobile on emergency power and running 200 watts or less (cw or PEP phone) inside Florida but outside of their home counties. Class "B" stations are all other stations operating in Florida.

EXCHANGE: Florida stations send signal report and county of operation. Out-of-state stations send signal report and U.S. State, Canadian province, or country; out-of-state mobile stations not operating within the jurisdiction of any country send signal report and the ITU region (1, 2, or 3, etc.) in which operating.

SUGGESTED FREQUENCIES: cw - 3555, 7055, 14055, 21055, 28055 phone - 3945, 7279, 14319, 21379, 28579, 50.2, 146.52

SCORING: Florida stations count one point per QSO with out-of-state or other Florida stations. Multiplier is the sum of states (49 maximum), provinces (12 maximum), DX countries (25 maximum), and ITU Regions (5 maximum) actually worked; maximum multiplier is 91. Out-of-state stations count two points per QSO with each Florida station. Multiplier is the number of different Florida counties worked (67 maximum). Score is the product of QSO points and multiplier. Class "A" stations ONLY multiply score by 1.5 (one and one-half) to obtain total.

AWARDS: Certificates, phone and cw, to the top single-operator score in each state, province, and DX country, and each Florida county. There are also five plaques to be awarded as follows: high single-operator in Florida and out-of-state, cw and phone, and to the Florida club with the highest aggregate score.

DISQUALIFICATIONS: At the discretion of the contest committee, stations and/or operators may be disqualified for improper reporting, excessive dupes, errors in multiplier lists, unreadable logs, obvious cheating, etc. Anyone disqualified in this year's Florida QSO Party will be barred from the contest next year.

REPORTING: PHONE and CW entries are to be SEPARATED. Along with legible logs in chronological order, a summary sheet is required with each entry. The summary sheet must contain score, number of QSO's, multiplier, stations call sign, entry class and number of Florida counties, power source for Class "A" entries; state; province; country or region of operation; call signs of all operators/loggers if multi-op; name of club if part of a club aggregate score; name and address typed or printed in block letters; and a signed declaration that all rules and regulations have been observed. Include a 15¢ stamp for contest results from a future issue of FLORIDA SKIP.

DEADLINE FOR ENTRIES: All entries must be received on or before 15 June 1980 (late DX entries will be accepted within reason). Mail all entries to: Florida Skip Contest Committee, P.O. Box 660501, Miami Springs, Florida 33166.
