MINUTES OF THE MARAC MONTHLY MEETING

The May MARAC meeting was held on May 10, 1986 at the Holiday Inn, East, in St. Paul, Minn. The meeting was called to order by WBØTVL at 9:00 AM. Present were: WBØTVL, WØKMH, W9LHG, NØDRX, WØNNH, WØHKF, NØAKC, WAØLKL, WØOWY and WBØUPU.

The minutes of the April meeting were read. Motion to accept by WØNNH, second by WØKMH, approved.

The Treasurer's report was submitted by W9LHG. After review and discussion, motion to accept by WØNNH, second by WØKMH, approved.

WØOWY reported on behalf of Vern, WAØRJJ, Chairman of the Constitution and Bylaws Revision Committee, that the Committee was still at work and after receiving feed-back from some members in other parts of the country would most likely have additional suggestions for the membership at large. It is planned to possibly mail any additional proposals to all members for their review and consideration.

WBØTVL reported that the awards formerly associated with the CW group have now been incorporated into the general MARAC Awards packet and after a few refinements will be made available to all members.

WBØTVL announced that the Secretary, WBØUPU will once again head the group of members responsible for coordinating the Annual MARAC Report. WBØUPU added that requests for input have already been sent out and the Report will be available to those attending the Convention in Asheville and by mail after that date.

A general discussion was held regarding the Convention in Asheville. The Secretary reminded those present that the Convention would be from July 9. through July 12. Early registration is encouraged so the planners, N4ANV and KC4IF and their committees can project attendance, etc. In addition, members returning their registration by June 15 will be eligible for a new Icom 735 to be awarded in a special drawing.

The next MARAC meeting will be on June 7, 1986 at the Holiday Inn. Note that the July meeting will be held in conjunction with the Convention in Asheville.

There being no further business, the meeting adjourned at 10:30 AM.

Here is "one" answer to last months puzzle. One day a gentleman by the name of Millman came up with an idea that if all you need to know is the voltage common to a group of parallel branches, a little algebra could simplify the task. He took the old standby, $V=IR$, and expanded it some, using I as a total current I and R as a total resistance R_t . We know that $I_t = I_1 + I_2 + I_3 + \dots + I_n$, and that $R_t = 1$ divided by $1/R_1 + 1/R_2 + 1/R_3 + \dots + 1/R_n$. These are the normal parallel circuit equations. When substituted into $V=IR$ it takes on the form of $V_{xy} = V_1/R_1 + V_2/R_2 + V_3/R_3 + \dots + V_n/R_n / 1/R_1 + 1/R_2 + 1/R_3 + \dots + 1/R_n$. The reason for the V/R form on top of the fraction bar is because the I term was not given directly. V and R are given, so a substitution was called for and this was from $I=V/R$. The formula is now in a form that we can use with the values given, and it is called Millmans' Theorem. Combine the resistors in the first two legs: $R_1 = 47 + 82 = 129$ ohms, and $R_2 = 22 + 56 = 78$ ohms. Number the legs or branches 1 through 5 as shown, and name the resistances and voltages accordingly. Sub in the numbers: $V_{xy} = 90/129 + (-100)/78 + 40/91 + 0/10 + 25/63 / 1/129 + 1/78 + 1/91 + 1/10 + 1/63 = .6977 - 1.2821 + .4396 + 0 + .3968 / .0078 + .0128 + .0110 + .1 + .0159, V_{xy} = .2520 / .1474 = 1.7093$.






CW COUNTY HUNTERS

1986 MARAC County Hunters CW Contest

MARAC invites all amateurs to participate in the 1986 County Hunters CW Contest. All mobile and portable operation from less active counties is welcomed and encouraged.

RULES

- 1) Contest Period: 0000Z July 26 to 0200Z July 28, 1986
- 2) General Call: CQ CH
- 3) Exchange: QSO number, Category (Mobiles or Portables only: M or P), RST, County and State (U.S. Stations) others send Province or Country. EXAMPLE: 022M 599 ORANGE CA . Stations may be worked once on each band and again if the the station has changed county. Mobile or portable stations changing counties during the contest may repeat contacts for QSO points. Stations on county lines give and receive only one number QSO, but each county is valid as a multiplier for the receiving station.
- 4) Scoring: QSOs with fixed stations are 1 point, QSOs with mobile or portable stations are 3 points. The Total score is obtained by multiplying the sum of all QSO points by the number of U.S. Counties worked. Independent Cities may be counted as any one of their adjoining counties in accordance with USACA rules. Mobiles and portables who change states during the contest calculate their score for each state separately and again for total score.
- 5) Suggested Frequencies: 3575, 7055, 14065, 21065 and 28065. On 20 and 40M, mobile and portable stations should call CQ or QRZ below the suggested frequencies. Fixed stations will CQ or QRZ above the suggested frequencies.

6) Awards:

Certificates will be awarded in three categories:

- F - Highest scoring fixed or fixed portable station in each state, province (Canada) and Country when total score exceeds 1000 points.
- P - Highest scoring station in each state operating portable from a county which is not his normal point of operation when total score exceeds 1000 points.
- M - Highest scoring station in each state operating mobile from 3 or more counties with a minimum of 10 QSOs in at least each of 3 counties.

Plaques will be awarded to the highest scoring mobile, portable and fixed stations in the U.S. who meet the above requirements for certificates.

Additional awards will be issued where deemed appropriate by the awards committee.

- 7) Submit contest logs showing category, date/time (GMT), station worked, band, exchanges, location, QSO points and Total Score. All entries with 100 or more QSOs MUST INCLUDE AN ALPHABETIZED LIST OF ALL COUNTIES BEING USED AS MULTIPLIERS OR BE DISQUALIFIED FROM RECEIVING AWARDS. Enclose a LARGE S.A.S.E. if contest results are desired. Logs must be postmarked by 1 September 1986 and sent to:



We would like mention in the periodicals requesting data of who was active, particularly from the "rare" counties. We also want to encourage that individuals send in logs for both the Sesquicentennial (Armadillo Run) Contest and for the County Hunters' Contest.

In the meantime, we are reviewing logs from key stations around the country and will have a fairly comprehensive list of active counties within two weeks. If we can assemble the additional data we've requested by 5/23, we will have a 95% accurate number to release by the end of May. At that point we will publish a list of counties that we will have to activate over the CW weekend in July to accomplish our goal of activating all of the counties in 48 hours of operating.

Entertainment was supplied by W7VSE and all of us whose singing voices so markedly improved after about the second beer. 27th ANNUAL NEW JERSEY QSO PARTY - AUGUST 16 - 17

The Englewood Amateur Radio Association, Inc., invites all amateurs the world over to take part in the 26th Annual New Jersey QSO Party.

RULES: [1] The time of the contest is from 2000 UTC Saturday August 16 to 0700 UTC Sunday August 17 and from 1300 UTC Sunday August 17 to 0200 UTC Monday August 18. [2] Phone and CW are considered the same contest. A station may be contacted once on each band - phone and CW are considered separate bands - CW contacts may not be made in phone band segments. New Jersey stations may work other New Jersey stations. [3] General call is "CQ New Jersey" or "CQ NJ". New Jersey stations are requested to identify themselves by signing "DE NJ" on CW and "New Jersey calling" on phone. Suggested frequencies are 1810, 3535, 3900, 7035, 7135, 7235, 14035, 14280, 21100, 21355, 28100, 28610, 50-50.5, and 144-146. Suggest phone activity on the even hours; 15 meters on the odd hours [1500 to 2100 UTC]; 160 meters at 0500 UTC. [4] Exchange consists of QSO Number, RST, and QTH [ARRL Section or country]. New Jersey stations will send county for their QTH. [5] Scoring: Out-of-state stations multiply number of complete contacts with New Jersey stations times the number of New Jersey counties worked [maximum of 21]. New Jersey stations: W-K-VE-VO QSOs count as 1 point; DX stations count as 3 points. Multiply total number of points times the number of ARRL sections [including NNJ and SNJ - maximum of 74]. KP4, KH6, KL7, etc. count as 3 point DX contacts and as well as section multipliers. [6] Certificates will be awarded to the first place station in each New Jersey county, ARRL section, and country. In addition, a second place certificate will be awarded when four or more logs are received. Novice, Technician, and mobile operator certificates will also be awarded. [7] Logs must also show UTC date and time, band, and emission, and be received not later than September 13, 1986. The first contact for each claimed multiplier must be indicated and numbered and a check list of contacts and multipliers should be included. Multi-operator stations should be noted and calls of participating operators listed. Logs and comments should be sent to: Englewood Amateur Radio Association, Inc., Post Office Box 528, Englewood, New Jersey 07631-0528. A #10 size SASE should be included for results. [8] Stations planning active participation in New Jersey are requested to advise the EARA by August 1st of your intentions so that we may plan for full coverage from all counties. Portable and mobile operation is encouraged.

A Hint for Mobiles who use a bumper mount from KA2CNG:

Ever since I have been mobile I have been plagued by two problems with a bumper mount. Corrosion and vibration keep breaking the coax connection at un-opportune times. Lately I have carried a soldering iron and a 25 foot extension cord on all trips to fix the problems. No more thanks to Radio Shack. They have a new part for CB'ers that when us hams find out about it will probably give them more business. They have a 3/8 inch 24 thread mount with a PL259 connector on the other end. So instead of soldering the center lead and braid on the coax of a standard bumper mount you can just plug in your connection for a corrosion and vibration proof connection. When I travel to N. Carolina convention this summer I plan to leave the soldering iron and extension cord at home. The Radio Shack part no. (new for 86) is 21-961 and cost \$4.29.

W7HRD Ed-- I have been in County Hunting nearly one year and am enjoying it a lot. I have even gotten the bug to put a rig in my car, so I can enjoy the game from the other end, and perhaps give out some SW Arizona counties someone needs. However, it's been about 30 years since I last looked into putting a rig into a car. Then, it was vibrators, generators and tubes; now it is direct DC, alternators, and rarely a tube. I need to bone up, to go mobile today. As a suggestion, perhaps some of the mobilers could care to put a short description of their mobile setup into the Newsletter- or share some comments on what works or doesn't work. Perhaps some comments on antennae too. All of this to help "fixed" station guys like myself, who have no idea at all what it takes equipment-wise to go mobile. In the old days, my mobile friends in NY usually put a 2nd battery in their car. Is that still common practice? Noise reduction from the ignition always used to take super-human effort...does it still? We used to drag chains, to bleed static electricity from car to ground ?? Topics I'd like to hear about include Power systems, noise problems, where to run the wires, what transceivers to use (new/used, etc), antennae and tuning (where to run the coax), where to buy mobile equipment and parts.

Now, to add fuel to the fire- on a commonly debated topic on the nets; I think phonetics are useful, even on a mobile net, even if it slows the net down a bit. While no one approves using phonetics to swamp the competition, that is rarely the reason phonetics are used. Phonetics sure save a lot of mis-directed MRC's (I may be before I get KA4SAX's call right) Keep up the good work. My thanks to hundreds of mobilers who have given me counties.. 73, Ed.
