## MINUTES OF THE MARAC DECEMBER MEETING

The meeting was held on December 5th, 1987 at the Holiday Inn East, St. Paul, Mn. President Don, WAOLKL, called it to order at 9:10 AM. He was early this month. Also in attendance were WONNH, WBOKIN, W9LHG, WOKMH, WBOTVL, WAORJJ, WBOUPU, NOAKC, AND Luke, KDXOX, grandson of WBOTVL.

There was unanimous appreciation expressed to Bob, KOAYO, for the very attrative format of the December Roadrunner.

The Minutes of the MARAC meeting conducted at the SE (Manchester) Mini on Nov. 7, 1987, were presented for approval. Jim, WBOTVL, requested that an addition be made to indicate that the Minutes were provided by Pauline, N9CLZ. With the addition noted, W9LHG made a motion to approve the minutes, seconded by WBOKIN, passed.

The Minutes of the November MARAC meeting conducted in St. Paul were presented for approval. Jim, WBOTVL, reported the following correction received from Bill, WOOWY. The November Minutes incorrectly reported that the Awards Chairman would be asking MARAC Directors to become a permanent part of the Awards Committee. The Minutes will be corrected to indicate that there was discussion about making MARAC Directors a permanent part of the Awards Committee, but it would not be done. With the stated correction made, WONNH made a motion to approve the Minutes, seconded by W9LHG, passed.

John, W9LHG, presented the Treasurer's report. With no special items to report, other than the Secretary still owes him a muffin, WBOKIN made a motion that the Treasurer's Report be accepted, seconded by WONNH, passed.

The Awards Chairman reported via the Secretary some of his work in updating the Awards Program. He further asked for discussion and a vote of confidence for spending \$1000 or less in specific award design and certificate printing costs. After discussion, WONNH made a motion to give the Awards Chairman the requested vote of confidence for the Award Program expense, secdonded by WAORJJ, passed.

The Secretary indicted that at the end of November MARAC active membership was up 11 from the previous month.

The next MARAC meetings in the Headquarters area will be on Jan 9 and Feb 13, 1988 at 9 AM, also at the Holiday Inn East, St. Paul, MN.

#### WAS THIS YOU???

#### OR IS THIS YOU!

Since taking responsibility for the Custodianship of MARAC Awards, I have seen a number of things that need to be clarified regarding the awards. For the most part, all the items listed below happened with regular club members.

My thanks to Dave, W6CCM for coining the phrase "Was this You?" as it is very appropriate for these comments. You should ask yourself, "Did I do that?". Please remember that with everyone helping and doing their part accurately, the awards program will flow much more smoothly.

When you ordered the Last County Award, Cat. 2, you didn't use an application and didn't provide the information needed. I couldn't send the certificate.

Was this you? When you used a non standard application form for Last County, did you think about the fact that it would have to be recopied so it will fit in the file?

Was this you?
When you sent cash instead of a check, did you think that I would have to write a personal check for that because the MARAC account is in Minnesota & I don't want to send \$\$ thru the mail.

Was this you?

When you held all your applications for a year at a time, did you think that the recepient needed that Last County Award in order to obtain the Category Three award. Or think that the recipient moved and left no forwarding so I have no way of getting his award to him. Or think that he may have become a Silent Key and no one can get an award to him.

Was this you?
When you asked for an endorsement that is not offered, what did you expect to happen. Did you bother to check the award guidelines?

Was this you?

And when you checked the guidelines, did you bother to check the current guidelines or just pick up one of the old ones cause it was handy. Thereby asking for something that is no longer available or has changed.

Was this you?
When you requested the new Cliff Corne certificate, did you check to see if it had been reprinted yet? (It hasn't!)

Was this you?
When you moved, did you notify MARAC of your change of address. If I don't have the current address, it's hard to send awards to you.

Was this you?

Did you put the full address of the recipient on the Last County Award Application? If he is a current member, I have his address. If not, where do I send his award? Should I send it to you if you didn't provide the address?

Was this you?
When you requested a specific date, did you realize that you may hold up other award applications until I can process yours? Is this fair?

Was this you?

When you didn't bother to fill out the Right Hand end (the Stub) part of the application form, did you stop to think that the recipient will not know what contact the award is for?

Was this you?
When you sent \$1.00 for the certificate, I would like to know where have you been. The basic award fee is \$1.25 and has been that for years.

Was this you?
When you sent in multiple Last County Award applications copied on 8½ X 11"
paper without cutting the forms apart, did you stop to think that I would have to take the time to do that?

Was this you?
When you listed the Last County on the Application form as a County Line, what did you really want. The award is for 'A' Last County, not a line.

Was this you?

When you sent cash through the mail, did you stop to think that you may have just contributed to the retirement fund?

Was this you?

I think the key message in all of this is that if we all do our part and try to follow the guidelines and policies, all awards will be processed in a much more timely and proficient manner. Use a standard form. Fill it out complete. Do NOT send money. Do NOT hold your applications. Check the fee list in the guidelines. Pick one or the other of the County Line Counties as the Last Coun Keep reading the Road Runner for the latest info on Awards. As of January 1 all applications received that are incomplete or do not meet the guidelines will be processed last. Applications received with cash will be returned. Thanks to the majority who do it correctly and thusly help us all out.

LAST COUNTY AWARD

(The following letter was sent to Vern, WAORJJ and is being included for everyone to read. Editor)

Dear Mr. Olsen,

I have very sad news to report, my dear Ellis, GW3CDH, died on October 16. His amatuer radio activities meant so much to him. He had been a radio ham for over forth years. He was so enthusiastic over County Hunting and was especially fond of anything to do with America and thought his American friends were great. We came over to two conventions in 1980 and 1984 and loved every moment, we were met with great kindness and were planning to visit you lovely country again. He had suffered several minor strokes over the last two years, then a month before he died he suffered a massive stroke which robbed him of his speech and badly damaged his eyesight and he could only use his left arm. I am fortunate though as I - attended by family and friends - about 500 people attended his funeral and I've been amazed at the number of letters, etc., I have received showing how much he was loved and respected. He used to go around the country giving talks at radio clubs about his County Hunting activities and was very popular and much in demand One day I would like to visit America again in his memory

This is concurrent to a sentence of 18 years for contempt of court....efforts are under way to transfer them back to their home (Canada).

Early in the afternoon (Nov 5th--a typical day) there were nineteen (19) mobiles on the list on the phone net (Thursday). Imagine a prospective county hunter in his new mobile rig tuning in the net to find there are 19 mobiles ahead of him waiting to run! Each mobile gets 10 minutes (often more) for his run so the prospective new member would have a three hour wait, by which time he would be clear across the state and half way into the next. At the same time mentioned above, there were just two mobiles running on CW with no net control--net in open session. It seems to me we ought to chase some of these guys down to the CW net once in a while and allow a little room for prospective newcomers to at least get a word in edgewise! My hat is off to anybody who works all US counties on CW. With such a terrific imbalance in activity between the phone and CW nets they at least deserve an oakleaf cluster on their certifictes for their efforts.

A big THANK YOU from the holder of USACA #551. For me the search began on June 30, 1979 with my first contact on 14.336 and ended on July 7, 1987 with Choteau Montana given to me by KC70D. In between it has been lots of fun and has also given me the opportunity to meet many of the mobiles and fixed stations that hang around the County Hunters net. I have attended the national conventions in West Virginia and in North Carolina. I also attended the first two mini conventions held in my home state of New York. Since 1983, I have run

mobile myself. I was first licensed in 1978 and after I upgraded to General, my Uncle, WB4AIL, introduced me to the County Hunters. Over the years the rules have changed some, there have been numerous heated debates over procedures, but for the most part the more important aspects of the County Hunters has remained intact. W4RKV--One of the frustrating experiences most of us have faced on the net at one time or another is being unable to hear either the primary or assistant net control. Whether due to propagation conditions, geographic location, or other factors beyond our control, it is aggravating when we cannot hear either of the control stations. Fortunately, this woeful situation can be easily overcome, and best of all it is cheap! Very few things in life are 100% effective and cheap, but this one meets the test. It does not require the expenditure of big bucks for a KWM-380, Alpha 77DX, 140' tower. and stacked seven element monobanders; in fact, the actual monetary outlay is practically nil. Too good to be true? Read on. If properly implemented, this setup will effect certain immediate advantages. For example, you will ALWAYS: a) Be able to hear the NCS b) Know what county is being run and by whom (no more Whats The County and Whats Your Call inquiries) c) Have an excellent chance to work every mobile that is run, if they are at all readable. (Another result is that a lot of people on the net will get to know your name. This can be good or bad, depending on your point of view.) To end all the frustrations listed above requires that you perform only one simple act --- tune to 14.336 and transmit the following words; "I will pick up the net." Once you have picked up the list, you have my absolute 100% money-back guarantee that you will be able to hear the NCS.

### Operating Guidelines

#### 3.0 SSB NET OPERATING PROCEDURES


- 3.1 GENERAL- The following describes typical procedure used on the County Hunting Nets. Actual procedures and techniques will vary from these according to the experience of the participants and the judgement of the NCS.
- 3.2 PURPOSE AND PRIORITIES- The first priority of the nets is emergency traffice, particulary from mobiles. The second priority is running mobiles in counties. These priorities take precedence over any other activity on the nets.
- 3.3 OPERATING FREQUENCIES- 14.336 mHz is the home of the Mobile Emergency and County Hunter's Net. It is in operation all day, every day.

7.249 mHz is primarily a calling frequency used by stations that cannot make contact on 20

meters.

- 3.865 mHz is used for net operation in the evenings of the winter months.
- 3.4 MODE OF OPERATION- These procedures apply to two-way SSB operation. CW contacts, on the SSB net are disruptive to the net and are discouraged. Moreover, cross mode contacts are not valid for USA-CA and MARAC awards.
- 3.5 PRIVILEGES OF THE NET CONTROL STATION- The NCS and the relay stations are in the position of being able to make contacts that are not available to other stations on the net. They should be very careful no to abuse their position. This applies to queries as well as to county contacts.
- 3.6 WARMUP SESSION- County hunters will begin to gather on or near the net frequency prior to the formal start-up of the net. A preliminary period is usually necessary to establish control of the frequency. The county hunters should never attempt to gain control of the frequency if it is already in use. a nearby frequency should be selected temporarily.
- 3.7 DETERMINING THE NET CONTROL STATION- The NCS is always determined on a volunteer basis. Location of the NCS is not critical. It is the relative locations of the NCS and the relay staions that is important. Control may be assumed for any length of time but a minimum of one or two hours helps to maintain continuity and reduces the loss of time associated with changing net controls. The NCS should give some advance notice of when control will be relinquished. This alerts others who may wish to assume NCS.
- 3.8 STARTING UP NET OPERATIONS- The new NCS should announce "This is WOABC assuming net control of the Mobile Emergency and County Hunting Net. My Name is Joe and I'm located in Logan county ND." The NCS should also make a; short statement on the purpose of the net and tell how the listener can obtain more information about the net. The NCS will then ask for one or two stations to assist as Relay stations (Assistant Net Controls)
- 3.9 CALL FOR MOBILES- The NCS should periodically put out a call for new mobile check-ins. Mobiles are recognized and added to the list in the order in which they are heard. The NCS then should ask the relay station to put out a call for new mobile check-ins. The NCS should make a special effort to give every mobile an opportunity to check-in.
- 3.10 WHEN MOBILES MAY CHECK-IN- Mobiles should check into the net when NCS calls for check-ins. Alternately, the mobile should break the NCS or relay station, between mobile runs, and ask to be checked into the net.
