(Editors Note: The following information was cut from last months column due to lack of space. I forgot that it was promised the previous month. Bob, KOAYO) The CW Net is informal so no formal QNI (check-in) is required and none of the following is engraved in stone. Common sense prevails. If a mobile knows who the NCS is, simply call that station, identify and state your situation. "QRV (ready) in Blank co. MO" or "Will be QRV at such-and-such time." The NCS will exchange reports with you and will ask if there are any other mobiles ORV. If so, the NCS states "XYZ you are nr. 1 (or 2, etc) QRZ (standby) or QSY?" That mobile will then state his preference, ORZ or OSY up or down to run his county. The NCS will direct nr. 1 mobile to run his county. The mobile acknowledges and commences "CHN de NOXXX/M in Hickory co, MO QRZ?" The mobile may identify one station at a time or take a list. Identify and state your county periodically. When the mobile no longer hears any stations, ask "OSP?" The NCS will then feed in any relays. When completed, the NCS will query the mobile as to his next county. The mobile states his next county, if any and the approximate time in minutes to be QRV in that county. Again, if you are going mobile it is a good idea to announce your trip as far as possible in advance.

Some Q(operating signals) QNC (information for the net.) QRZ? (will you stand-by or I will stand-by). QSX (generally meant to indicate that station is listening QNZ (zero beat my signal. Used only by the NCS) QSY: (change frequency up/down) Generally when a mobile QSY's on 20 meters he will go to 14.070 if that frequency is clear. If to 40M to 7.035. There is no formal 80M frequency. QRS; (send more slowly) DON'T be timid about using QRS. However, you should send at the speed you can receive. The NCS normally sends at about 20 wpm, slower if necessary. Sometimes a station will not slow down for you. Ignore them and pick out the ones you can copy. If the fast station wants the county he will slow down. QNF: (the net is free, in open session) Many times there will be no NCS and the net may seem dead. If mobile, throw in a CHN CHN de NOXXX/M QRV, Blank co, MO. If no one returns go: CHN CHN de NOXXX/M in Blank co, MO. QRZ and go.

(Following is the "CW NEWS" from Harry for the month.)

For those whom I promised a "quick-fix" CW Net procedure last month, sorry but the "space-bug" i.e., lack of space in the Newsletter, got us. Anyway, the new CW procedures will be printed in their entirety, thanks to Howie WA4KER for all his work. Some have asked what is "Bingo?" "Bingo" is actually the Master County Hunters Award that somehow became known as "Bingo". It is issued by the Mobile QSL Bureau and is not a MARAC Award. Basically, you must work a mobile in every county where a letter in the mobile's suffix is the same as the first letter of the county being worked. There are some wild cards. If the mobile is a USA-CA holder, he counts for any county.

If the mobile has an "X" in his suffix, it is wild. There are other combinations and to find out, send a business sized SASE with two units of postage to the Mobile QSL Bureau and ask for the County Hunters Information. Having earned the Plaque for the Master CH Award I can assure you it is very attractive and well worth working for. Open to all.

From Tom, W2EZ, comes the info that he is planning his Indy convention trip and would like to hear from folks who need counties from NY to Indy. Not planning much interstate he says. After requests are in he will plan and publish his route to be the most productive to those folks who are in need. Folks, do us a favor. Just send your needs to those you know are making trips and let them pick the most ecomonically productive route. What drives us up the wall faster than anything is to hear a request for a county 200 miles away! Don't know what my route will be yet. Depends on how many grandkids are demanding my time and how much time is available.

CW activity is picking up now. Happy to see new mobiles coming down and running CW. Some comments; "...didn't know it was this easy..." "..really having a ball..." "...don't you ever have a waiting list?..." "...it's a pleasure to be able to run all the counties I go thru..." You too can join in the fun and rid yourself of fustrations. Come on down and CW me some time (14.066.5 mHz).

The program uses a compiled version of dBASE III Plus which, together with "LIGHTENING", gives the program a fast response time. Program features include the following: Operating Aid; a) Counties remaining to be confirmed in each state. b) Last or next-to-last counties. Record Keeping; a) County totals b) Summary of completed states c) First contact QSL information d) List of counties worked but not confirmed prior to a selected date f) Counties obtained from a specific mobile h) Hard copy of all necessary data in an acceptable format for sending for the CQ Awards. i) etc.

4X11 inches in the shape of an 18-wheeler with a brass plate appropriately engraved.

All awards will be numbered.

MARAC Constitution and Bylaws Amendments -

Enclosed in this copy of the Roadrunner you will find a ballot for voting on three amendments to MARAC's Constitution and Bylaws, dated 10/4/86. Please vote. Your vote is important.

Amendment #1 - submitted by WAØRJJ, MARAC Secretary.

Bylaw Article VII - Dues, Fees, Assessments, Section 2, Paragraph 2, currently states "All applications or renewals must be received by the Secretary by the 10th of the month in order to be effective the following month."

Discussion: The Secretary has been able to improve on using the 10th of the month, and currently uses the 15th of the month.

Suggested revision to state: "All applications or renewals must be received by the Secretary by the 15th of the month in order to be effective the following month."

Amendment #2 - submitted by WAØRJJ, MARAC Secretary.

Bylaw Article VII - Dues, Fees, Assessments, Section 1. Dues, Part A currently states "Annual Dues shall be \$8.00, in U.S. funds, for North American individual and family membership, with newsletter mailing via Third Class Mail."

Discussion: Part A incorrectly states both the intent and current practice used for assessing dues. Third Class mailing cannot be done to either Mexico or Canada, and therefore, the term "North American" in Part A is incorrect. Moreover, Third Class mailing is allowed to all the U.S., including Possessions.

Suggested Revision to state "Annual dues shall be \$8.00 for individual and family memberships within the United States, with newsletter mailing via Third Class mail."

Amendment #3 - submitted by WAØLKL, MARAC President.

Bylaw Article VII - Dues, Fees, Assessments, Section 1. DUES, currently states:

Section 1. DUES.

- A. Annual dues shall be \$8.00, in U.S. funds for North American individual and family membership, with newsletter mailing via Third Class mail.
- B. Annual dues with First Class mailing of the newsletter for North American members will be \$11.00 in U.S. funds.
- C. Annual dues with newsletter mailing via Airmail, to all other continents/countries other than North America, will be \$20.00 in U.S. funds.
- D. Members of the Board of Directors shall be entitled to pay annual dues of \$8.00 and receive newsletter mailing via First Class mail.

Discussion: An increase in membership dues is felt to be necessary in order to meet the increasing costs of MARAC services. In short, a dues increase of \$2 - Third Class n/1, \$2 - 1st Class n/1 to N.A., and \$5 - DX, is recommended. Some of the factors input to this recommended dues increase are:

- Significant postal rate increase, both for Domestic and International mail service.

- DX, excluding Canada, dues have not met costs.
- Support of the MARAC Information Packet program.
- General administrative expense.
- Larger newsletters.
- Special mailings to the membership, like the Annual Report.

Suggested Revision:

Section 1. DUES.

- A. Annual dues shall be \$10.00, in U.S. funds for North American individual and family membership, with newsletter mailing via Third Class mail.
 - Annual dues with First Class mailing of the newsletter for North American members will be \$13.00 in U.S. funds.
 - C. Annual dues with newsletter mailing via Airmail, to all other continents/countries other than North America, will be \$25.00 in
 - D. Members of the Board of Directors shall be entitled to pay annual dues of \$10.00 and receive newsletter mailing via First Class mail.


Important Voting Instructions

The minutes of the March meeting were presented for approval. WONNH made a motion to accept the minutes as reported in the Road Runner, seconded by WBOKIN, passede. John, W9LHG, presented the Treasurer's report. After some discussion and explanation of the detail items listed, WAORJJ made a motion to accept the report, seconded by WONNH, passed.

President Don, WAOLKL, reviewed some correspondence received. N9DEH announced his "Big Rig Award". Dorothy, WB9RCY, clarified that there is no change regarding Hawaii (Kalawao) or Alaska counties.

There was extensive discussion of a potential dues increase to meet the increasing costs of MARAC services. With unanimous approval, President Don volunteered to author an amendment to the Constitution and ByLaws, to be voted on by the membership. The proposed membership dues would be increased to — \$10/yr 3rd class mail to the US; \$13/yr 1st class mail to North America; \$25/yr Airmail to non-NA DX.

Vern, WAORJJ, led a discussion of the input required and distribution of the MARAC Annual Report. After discussion, it was resolved that the Annual Report would be mailed to all active MARAC members in the June 1st timeframe. May 15th will be used as the cutoff date for input. Bill, WOOWY, has volunteered to assist with the printing and distribution.

The 1991 National Convention was discussed. With a vote of confidence by those present, President Don will propose at Indianapolis that the MARAC Headquarters area be considered as the site of the 1991 National Convention. Don, WAOLKI, John, W9LHG, and Bob, WOKMH volunteered to be the potential tri-convenors.

Jerry, WONNH, made a motion to adjourn, seconded by Walt, WBOKIN, passed.

The next regular MARAC meetings in the Headquarters area will be on May 7th and June 11th, 1988 at 9 AM at the Holiday Inn East, St. Paul, MN.



CW OPERATING GUIDELINES CONTINUED

3.3 FREQUENTLY USED Q SIGNALS

QNI Used by the NCS to invite any station to check in or to break the Net for information or a query.

QNO Station is leaving the Net.

QNC Please copy the following information for the Net.

QSP I relay or please relay.

QRV Are you ready to copy, run, etc., or I am ready.

QNZ Please zero beat this frequency. QRX I will call you or I will stand-by.

QSX I will be listening.

QNF The Net is in open session. No Net Control.

3.4 NET CONTROLS

The CW Net seldom has a lengthy list of mobiles. Therefore, the emphasis on the need for and the duties of formally-organized NCS is somewhat reduced; i.e., the CW Net is somewhat more informal. Often the Net runs along, reasonably effectively, without a recognized NCS. However, it must be noted that with a NCS the CW Net runs with more order and relays are more efficient. Also, it is the duty of all Net members to try to assist the NCS or takeover when necessary. At times there will be more than two mobiles checking in; under these conditions the NCS SHOULD INVOKE THE TEN-MINUTE RULE; THAT IS, GIVE EACH MOBILE TEN MINUTES TO RUN HIS COUNTY. He may ask the running mobile to move off frequency to finish his run. (Obviously, this takes an experienced NCS to be able to make the correct decision.)

3.5 KEEPING A LIST OF MOBILES.

One difficult but very important duty of the NCS is to keep an orderly list of mobiles in order in which they should be run. Suggestions for maintaining the list are as follows:

- .1 Start with a list of mobiles arranged in the order in which they will be called to run their counties.
- .2 When a mobile runs a county, move the call of that mobile from the beginning of the list to the end of the list.

.3 Add new mobile check-ins to the end of the list.

A If a mobile runs off frequency, LEAVE THAT CALL IN PLACE ON THE LIST. THAT IS, AN OFF FREQUENCY RUN DOES NOT COUNT AS A TURN ON THE NET.

.5 If a mobile does not respond when called, call the mobile again in 20 or 30 minutes.

After two or three no-shows, remove that call from the list. If that mobile shows up later, replace his call near the beginning of the list.

.6 Don't give list priority to mobiles on special trips or on county lines. Do be especially

attentive to their needs for making contacts, moving off frequency, etc.

3.6 MOBILE CHECK-INS.

The CW Net is quite informal and a lot of initiative rests with the mobile. The NCS will usually ask for a mobile check-in after every mobile run. A second choice is to work a mobile that is running and tell him/her that you are QRV. A third choice, if a rag chew is in progress, indicate that you are mobile. Information breaks to announce a mobile running off frequency or a mobile break-in should be given priority. THAT MOBILE IS DANGLING IN THE BREEZE UNTIL AN ANNOUNCEMENT IS MADE ON THE NET THAT A MOBILE IS QRV. Often, when you tune to the Net frequency, you won't hear the Net. Don't be discouraged. That can be because there is no NCS and or no mobile running at the time. Just call "CHN de K5XYZ/M" if the net is active, someone will answer. Follow the instructions given by that station. If none are given, go ahead and run your county. The "CHN?" followed by the station's call is also used by fixed stations that want to inquire on the status of the Net. (continued next month)

3.20 KEEPING THINGS MOVING - Some of the things that can be done to facilitate runs and improve the efficiency of the net are:

- 1 Don't stretch short runs. A short run allows extra time for other things. It will be needed.
- .2 Don't milk the relays. Take one list and stop.
- .3 Limit the number of tries that a station gets.
- 4 Take relays from one direction only.
- .5 Don't take relays.
- .6 Be firm about queries.
- .7 Don't ask the mobile to make a last call.

3.21 BREAKING STATIONS - The proper time to break the net depends upon the urgency of the information being sought or passed. The following priorities should be followed when breaking the net:

1 An EMERGENCY is usually indicated be a double "Break - Break" and may be used at any time to break the net.

.2 A break to announce a mobile running off frequency is usually indicated by "Information Break". It is high priority and can be made during a mobile run but discrection should be used to hit natural breaks in the run.

.3 Routine inquiries are usually indicated by "Break" or "Query", and may be handled between mobile runs, if at all. Such inquiries should be greatly limited during busy mobile periods - a more appropriate time would be during "Calls, Comments and Queries". Also, see Section 3.20.

3.22 CALLS, COMMENTS AND QUERIES. During periods when there are no mobiles ready to run and Net activity is at a slow pace, the NCS can keep the frequency occupied by announcing — "Any calls, comments or queries? WOABC, Net Control." This is a general invitation for any station to make a directed call to another station, make a general comment, ask a question, inquire about log information, announce planned trips, etc. When several stations respond, a call list is developed by the NCS in the same way as the mobile list. Stations are acknowledged in the order that they are heard and asked to make their calls. The NCS should limit the number of stations on the list so that a frequent check for mobiles can be made. A mobile wanting to run a county always takes priority.
