Net Operating Tips

By Mitch, W4RKV

Many Newcomers (and some not so new) to our net either have not read the CH guidelines in the Handkbook or choose to ignore them. One of the most frequently abused is section 5.5.10 dealing with trivial queries. It describes a station's request for a particular county from a mobile as a trivial query, unless it is the last county in that state or one of the last 50 in the country. While this may seem a bit restrictive, we have to draw the line somewhere. Using myself as an example, if I hear a mobile in north Texas and interrupt to tell him I only need 9 more in Texas and 3 near him to finish up that part of the state, THAT IS A TRIVIAL QUERY. Why? Because what's fair for one is fair for all, and if EVERYONE listening on the net who needs counties in Texas interrupted with the same info, we would average about 2 or 3 mobiles an hour. We should keep in mind that (usually) there are other mobiles waiting to run, and people waiting to work them. If I make arrangements OFF FREQUENCY or by letter/telephone for a specific county, I should always offer to move the mobile off frequency so that others who need that county may benefit from the interruption.

Dateline CW

"Nothing is so insignificant it can't be blown out of proportion."

Talk about being confused, which I have mastered without formal training. What is confusing me is the statement in the January Newsletter where a CHRC was returned because the signal report was wrong. Somewhere I have missed some-

thing. I looked at my yellowed dogeared CQ USACA logbook and there is not a field for a RS(T) entry. When in doubt read the instructions, and there it was. MARAC Rule w.4 requires only written confirmation of a contact, which by definition, must be a signal report of 22(T) or better.

Being a Florida cracker by marriage I inherited oxymoron red neck logic and, it would seem to me a 56(T) sihnal report that was incorrectly written on the CHRC as 59(T) is still a valid contact. I reason thusly, both the 56(T) and the 59(T) signal reports are greater than 22(9) the minimum acceptable report, therefor, by definition, the contact is valid.

Then follows the obvious question "Why would an invalid contact be logged?" This is very confusing to me, will someone out there please explain what parameter I have overlooked.

The thril of a victory is more fun than the agony of defeat, but can be dangerous. On February 25, Harry, NFOX, gave me Newton County, my last Texas county. I raised my arms in victory, leaned back and gave out a rebel yell. Unfortunately, my chair leaned back to a horizontal position putting me in an unstable position.

My momentum was abosrbed by a lawn chair on which was sleeping my cat Tiger. The cat was catapulted through the air. Seeing a 19 pound cat flying, fangs out and shrieking like a wounded tornado is enough to over-saturate the best Depend. Tiger landed on the operating table, ran in place for a second and bolted out the door. In one split second Tiger had transmitted CQ CHN, shredded my log, dumped coffee in my keyer and picked up frequent flyer mileage. Then on March 15, Ed, WA6VJP, gave me Eureka County, my last in NV.

Tiger was sleeping on his chair during the contact and as I was keying, TX Ed for my last....Tiger bolted out the door. Who says cats cannot remember.

The county hunters 10 meter CW contest was fun even if the conditions were not the best. I covered 735 miles operating from 14 FL, 11 GA and 2 AL counties. Hope we do it again next year and the conditions allow me to beat the 142 contacts made this year.

Next month is the CH convention, I am looking foreward to seeing all of you again and to meet many new CH'ers. So gas up the buggy, empty the piggy bank and lets all meet at the KING OF PRUSSIA.

March 29 while on a trip from Tampa to Gainesville I decided to run the counties along route 301. The weather was clear and warm with light traffic on the highway and low QRM on the CHN. As I entered Sumter conty I noticed a small cemetery down youder perched on a knoll about two hundred yard off the highway. That would be a good location from which to work the CW Net, so I turned onto the side road leading up to the cemetery.

I stopped at the entrance archway, on which the name Greenwood was inscribed, to consider passage of my antenna. It looked high enough, but I moved forward cautiously until well inside the cemetery. I checked the CW net and a mobile was running so I decided to exercise my legs by taking a short stroll. The dates on the head stones indicated this was a very old cemetery dating back to the 1800's. The ground were well kept and I could see why people were dying

to get in. I noticed several headstones in a section fenced separate from the main cemetery. My curiosity overcame better judgement and I walked over to this segregated area. The first thing I noticed was the fence around the graves. It was circular and without a gate, an unbroked circle. The fence was made of cast iron similar in design to the burglar bars used on store fronts. For some reason I noticed the fence had six vertical bars, a cross, six more vertical bars, another cross, a design that continued around the entire circle.

The main cemetery had a plush grass cover throughout, except this plot, which was bare of any growth. I did notice there were 13 graves within the circle and on each grave was an artificial black Rose stuck into the ground. It appeared each rose was located directly above the heart of the interred. I swore never to watch any more twilight Zone reruns on TV.

I noticed, what appeared to be a six inch square mirror, embedded in each headstone. On the first headstone was etched, Samual Jacobs 1806-1856, Thy Flames Delivered. The next read, Emma Rottweiler 1808-1838, Burn thee Clean. The headstone inscriptions did not make any sense to me, but I had this feeling these were the graves of people different from the majority of that period. What an idea for a story for the Roadrunner, a county run where a poltergeist or two may be listening. I went back to the van and parked it as close to the fence as possible. The air in the van suddenly seemed heavy so I left the engine and air conditioner running.

I checked the CW net just

in time to hear ANI/M QRV please QNI. I responded as usual, but was not acknowledged by the NCS, but the moment I unkeyed a low hum was received which increased to a S-5 before tailing off. During my second attempt to contact the NCS I looked at the meter and saw the output power slowly drop to zero, I unkeyed. There was that hum starting again, this time peaking at S-10 during which I noticed a strange phenomenon, the meter on the rig indicated increasing power output, yet only the receive indicator light was on. My curiosity overwhelmed my basic desire to get the hell out of there. I keyed down and out of the corner of my eye I noticed the black artificial roses were swaying back and forth, I unkeyed, they were motionless as death. There is the problem, the wire stems of the black roses must be the exact length to be resonant to the CHN frequency and produce a RF echo, which produced the hum between the antenna and the roses, a mobile RF choke. Suddenly it got dark as if a cloud had covered the sun, yet there were no clouds in the sky. I hit the keyer and pounded out, de KN4Y/M QRV in, then stopped, there was no sidetone, no indicated power output. The hum, now more like a scream from tormented souls exceeded S-40, I tore off the headphones now soaked in sweat, the black roses were swaying in unison, the van engine labored as if grasping for air, the MFJ clock indicated 0000. Sweat burned my eyes, I screamed, "Nothing is going to stop me from running Sumter county. The only response was complete silence, only the frenzy beating of my heart. Suddenly, all the van doors unlocked. (To be continued...)

Reduce ORM With a Tune Up Switch

Tune-up QRM is so common on the HF bands that we have come to accept it as part of operating, but it sure can be irritating at times. Part of the pride in operating a station is to be courteous to other hams (this means NOT interfering with their QSO's). Moving to a quiet area of the band to tune-up only lessens the probability of interfering with a QSO, since the receiving station can still be clobbered. If every ham that uses a transmatch in the antenna system were to use the tune-up indicator switch described by Wm Vissers, K4KI, in QST (Dec 1979, pg42) there would be a lot less QRM. If I were to recommend two things to a ham newcomer, it would be to have a dummy load (Heathkit's Cantenna is \$24.95 and worth it) and Visser's antenna switch.

When the switch in this unit is placed in the TUNE position, the transmitter is coupled to a 50 ohm dummy load, sending about 1% of that power to the antenna by way of a Wheatstone Bridge designed for 50 ohms. The transmatch in the antenna system is adjusted to null the bridge DC microammeter (0-50uA), indicating the antenna system is presenting a 50 ohm load to the transmitter. Then the switch is moved to the ANTENNA position, connecting the transmitter directly to the antenna system, and it is ready for operation. I have used this arrangement with my TS-520 Transceiver for about a year, with coax feedline to a tri-bander and open wi

wire feedline to a center fed wire for 40 and 80 meters.

A nice feature of the indicator-switch is that once a transmitter with tube finals is tuned (plate resonance) into the dummy load, no transmitter readjustments are needed after the transmatch-antenna adjustments are made. This system may have other advantages for broadband rigs with transistor finals. All transmatch adjustments are made with the transmitter looking at 50 ohms (dummy load) so the transmitter will not shut down even if a very high SWR occurs during transmatch tuning. On-the-air tests indicate my normal 10 watt, S9 tune-up signal is reduced to just above noise level when I use the indicator-switch unit. With the indicator-switch in the TUNE position, only about 100 milliwatts of power goes to the antenna, and even this can be reduced in many cases by using fewer toroid coil windings.

This is a nice project with relatively few components. Build and use this indicator switch and help reduce tune-up QRM.

Suggested freq for SSB are: 1.86, 3.92, 7.28, 14.28, 21.37, 28.37, 50.15 and 146.55.

Suggested freq for CW are: 3.643, 7.13, 14.04. 21.115, 50.05 and 144.15.


Maryland stations give RST and county (for this test only - DC and Balt. City will count as county multipliers). Stations outside of Maryland give RST and either state, province or DX country.

Certificates will be awarded in several categories including Maryland mobile, novice, tech, DX, top three MD scores and top score in each state.

Scoring - 5 QSO points for contact with club station, 3 points for mobile QSO, 2 points for MD CW station QSO. CW & mobile would be worth 3 + 2 = 5 QSO points. SSB QSO's with non-mobiles and non -club stations are worth 1 QSO point each. Final score = Total QSO points X total different county multipliers worked.

New Jersey 31st Annual QSO Party

The Englewood A.R.A., Inc. invites all amateurs to take part in the Annual QSO party to be held from 2000z Aug 18 thru 0700z Aug 19 and from 1300z Aug 19 thru 0200z Aug 20. Phone and CW are considered the same contest. A station may be contacted once on each band - phone and cw are considered separate bands - CW contacts may not be made in the phone band segments. NJ stations may work other NJ stations. Call CQ NJ or New Jersey. NJ stations are requested to identify themselves by signing "de NJ" on cw and "New Jersey calling" on phone.

Suggested frequencies are 1810, 3535, 3950, 7035, 7135, 7235, 14035, 14285, 21100, 21355, 28100, 28400, 50-50.5 and 144-146. Suggest phone activity on the even hours; 15/10 meters on the odd hours (1500 to 2100); 160

meters at 0500z.

Exchange QSO number, RST, and QTH (ARRL section or country). NJ stations will send county for their QTH.

Scoring; Non-NJ stations multiply number of complete contacts with NJ stations times the number of NJ counties worked (Max 21). NJ stations W-K-VE-VO QSO's count as 1 point; DX stations count as 3 points. Multiply total number of points times the number of ARRL sections (including NNJ and SNJ). KP4, KH6, KL7, etc, count as 3 point DX contacts as well as section multipliers.

Certificates awarded to the first place station in each NJ county, ARRL section, and country. In addition, a second place certificate will be awarded when four or more logs are received. Novice, Technician, and mobile operator certificates will also be given. A total of four plaques have been donated by the ARRL Section Managers for NNJ and SNJ to the highest scoring single operator station residing in each of their sections (separate for Novice/Technician and all other classes).

Logs must also show the UTC (z) date and time, band, and first contact for each claimed multiplier must be indicated and numbered and a check list of contacts and multipliers should be included. Multi-operator stations should be noted and calls of participating operators listed. Logs and comments should be sent to: Englewood Amateur Radio Association, Inc., P O Box 528, Englewood, NJ 07631-0528. A #10 size SASE should be included for results. Stations planning active participation in NJ are requested to advise EARA by Aug 1 so plans for full coverage can be made.


(Editor's Note: The following is an edited version of the letter sent from Jack to VE3FNM. It is printed at Jack's request and edited with his expressed permission).

WA9QNI, Jack - Mr. Will Phillips, VE3FNM. I would like to comment on your recent letter to the "Countyline Roadrunner" about county hunting being a frustrating experience for you. You do of course have the right to your opinions but in this case I feel your letter will cause some net control and mobile stations to quit trying and we don't have enough of them as it is. For every one person who would be so critical of the efforts of our great net control and mobile operators I believe there are at least "99" who would praise and encourage them. The other "99" take into consideration that this is not a large business nor a military operation but a volunteer group which offers no compensation nor benefits for time and effort put in. We offer no training, not even firm net proceedures to help or defend them. So we don't expect perfection and probably wouldn't recognize it if we heard or saw it and allow that no one can please all county hunters all of the time. The "99" do appreciate all the hours you mobiles spend after "giving" us a county (or a week of counties) listening to and transferring your tape or rough notes to some form of log and the hours you put in over the next 2 or 3 years going back over those logs to try and verify contacts for stations that don't always write or print clearly, often have the

wrong date, wrong county, wrong signal report, wrong call for the mobile, forget to put postage on the return envelope are not even on your log for that county (did he double with another station?) and many other careless mistakes which take 10 times as much of your time to process than the clean contacts do but he will still blame you if you fail to confirm the contact.

The "99" realize that no matter how often you really outstanding net control, relay, assistant and mobile stations announce the state, county and call (even with phonetics) at the start, during and at the end of the run, that many of we fixed stations were not paying attention. We certainly don't blame you for our own lack of attention nor for our rigs and/or antenna which most of us admit are inferior or poorly adjusted. We just wish there were 24 or 48 more half as good as you putting in just one-tenth as much time helping us get new counties.

And finally, we (the "99") regret that there will always be one who found our favorite radio activity so frustrating. We must remember that we did our best for them, wish them well, and understand. Remember then the "99" who stay around for the "Second Time Around", "Bingo", and the many other recognized variations of County Hunting. 73, Jack

KOAYO, Bob - HELP! I will soon be lowering the tower to replace my rotor and at that time I would like to establish a remote system for "antenna switching". Since my tower is about 150+ ft. from the shack, I am using only one coax feed line. There must be some sort of already-built switcher available and in use by one of you fine folks.

Also, does anyone have information regarding grounding towers, coax, rotor cables, etc. I have a coax switch with built-in lightning protection which I will put in the "new shack" but I'm concerned about the need to ground things at the base of the tower.

Second Subject. As some of you know, I retired from AT&T last December. What you might not be aware of is the fact that I am working again on a contract with them. Through the efforts of my wife, we have managed to keep your Newsletter coming more or less on the regular schedule by using the Postal Service between Kansas and New Hampshire. 

W5RIT, Dick - When reading a recent article in "CQ Magazine" about county hunters, K9KKX was written up and in the story it mentioned that he had formerly been licensed as KH6IB in Hawaii. Having spent a number of years as KH6AVO I looked back through my KH6 QSL cards and sure enough, found "KH6IB". We had QSO'd in January of 1954, 36 years ago. I wrote Ray about it and he replied, evidently having gone through his logs at great length, and reminded me that I had put out alot of counties for him, as far back as August 1967, plus several more in succeeding vears.

Ray recalled the "good ole' days" in Hawaii when we had unparalleled inter-island communication of 40 meters AM with no QRM. SSB was just coming in use. I earned a "worked 100 KH6" award; Ray won the "worked 200 KH6" award. During those early 50's years at a ham convention in Honolulu I came in second in a CW contest - the winner, "Nose", KH6IJ.

W2PDM, Stu - Regarding the proposal to eliminate the "T" from RST, I am grateful that

others are rising to find ways to shorten QSO's and mobile runs, as I have been expounding for some time. However, in this particular case, we should think twice about it. Last year, when NOCYB was running a county while off the road with his motor off, a severe chirp developed on his signal, which got progressively worse. Several people worked Woody and gave XX9 reports. When I worked him I gave 555 chirp, and he immediately started the motor. Later Woody told me that if I hadn't alerted him, he would have had a dead battery. Even if this type of problem occurs once every couple of years, it is worth the time to send a (dah-dit). A bigger time-saving would be if we could persuade the 10% of the CW ops who send 9 as (dah-dah-dah-dah-dit), (Editors Note: it also takes up too much room in the Newsletter), and never dah-dit, to use dah-dit. Also, some DX and the occasional ops would not get the word of such a change in procedure, and would get hopelessly confused, expecting a T in RST.



THE FIVE BAND AWARD

For quite some time we have had under review a potential change to the confirmations required for the Five Band Counties Award. The original proposal was for elimination of confirmation requirements for this award.

During follow-on discussions some other potential alternatives were reviewed. One of these was to require confirmations until after a person had received the MARAC Second Time award. Another alternative was to allow applications either with or without confirmations and a separate award numbering sequence would identify such holders for the appropriate publicity.

After discussions at some of the Mini Conventions and some letter writing, it was decided to solicit general membership help to determine the best solution to this question.

The proposals were summarized and published in the January County Line Roadrunner. A ballot card was included with that issue and everyone was encouraged to take the time to respond by completing the ballot card, writing in any appropriate comments and firing it back to the Awards Custodian.

Thanks to everyone that participated, we probably have had the finest response to any mail balloting that MARAC has ever had. The results represent all of the members and if you didn't vote you have no room to complain.

I waited until the flow of ballot cards materially slowed down and then started to analyze the results.

The Results

Based upon the results of the balloting we will not be making any change in the confirmation requirements for the Five Band Counties award. The largest single group responding wanted "No Change" and in addition to that, the results were so very mixed, the best solution is to make no change, at least at this time.

In addition to the breakout shown below, I also did an analysis by Call area, by holders of the USA-CA award or not, and by holders of the Second Time award or not. In all three of these cases the same trend is true, no clear cut trend is obvious.

For sake of brevity, shown below are the results by MARAC District. Congrats to the SE district for having the largest number of responses and also for having the best district participation. The SE District had almost a 30% member participation. The five possible category votes cast are shown across the top of the chart and the results by each district are shown under each category.

Except for the total line or total column the results are shown as a percentage of response within districts. The Total column on the right shows the percent of total responses for the district. The total line across the bottom show the percent of responses for each category.

The Comments

Most of the write in comments received appeared to follow the votes, at least in context. We received many long letters and they were excerpted so they could be included in the general comments.

A award means nothing if I had not earned it. A cheater has to live with himself. A novice or tech should not be eligible for the award. A sincere person is looking for actual accomplishments. Activity after getting the USA-CA # is for personal pleasure. After 1500 you would be on your honor. All claimed contacts must be fully logged at both ends. Allow endorsement to say with confirmations. Allow with or without confirms is a superior method. Allowing either is best choice especially for low incomers. Already have 1000 CHRCs that I have no other use for. Also eliminate confirmation requirements of all MARAC awards. Also no confirms after 2nd time award would be okay. Anyone really wanting the award should be willing to QSL. Anyone prostituting their integrity damages themselves only. Anything good is worth working for. As a hobby, we are supposed to be an ethical group. Award certificate available for unconfirmed contacts. Award obtainment by misrepresentation cheats on the awardee. Award would be very popular with out the expense of QSLing. Awards are dimished in value if too easily obtained. Awards are a personal achievement affecting no other person.

Believing mobilers locations should cause contact belief too.

(an't trust all because end justifies the means. Changing regulations would make it a rubber stamp. Cheaters will cheat no matter what the rules say. Cheaters can win awards but it is hollow empty victory. Confirmation required for most other ham awards. Confirmations must be required or award will be meaningless. Confirmations are a useful way of self checking. Confirmations should be required to go along with other ops. Confirmations should be required for all awards. Confirmations will separate given counties from earned ctys. Confirmations should be required to maintain integrity. Confirmations thru 2nd time okay with follow on verification. Confirmations are duplicates of those collected for CQ award. Cost becomes prohibitive after the first time. Cost is entirely too high to confirm for all five bands.

Do not like the dual system proposed (with or without). Do not cheapen the significance of this award. Don't change horses in the middle of the stream. Don't discount. Doubt that I will try this ambitious task.

Fliminate confirmations after 2nd time award is good step. Eliminate confirmations after 2nd time award is good step. Eliminate only for FBCA, all other awards remain the same. Eliminate for this award only. Endorsement saying no confirmations is a negative approach. Entire system of awards is based on integrity. Errors will be corrected by the confirmation process. Expense after I have done it a time or two is neglibile.

FBCA should not be awarded until all 5 bands are confirmed. For those that want to confirm, do it.

Guidelines to be set for verification for acceptance.

Hard enough to keep up w/ conf. contacts let alone non-conf. Has anyone actually figured the total cost to go 5 band? Honor is critical in this program. Hope that the majority opinion represents the club majority. How do we know the mobile is where he says he is.

I am a firm believer in confirmed contacts. I am old fashioned, I believe in honesty. I don't collect confirmations. I don't collect awards. I have no reservations about confirming all contacts. I know that I have worked the counties. I like the idea of indicating which way it is done. I personally confirm all contacts but this is burdonsome. I personally believe that no change is necessary. I prefer confirmations but essentially neutral. I

question the validity of awards without confirmations. I will be more comfortable having contacts confirmed. I wish I could find out what the rules are. I won't pursue this award if its too expensive or hard. I'd never look at an award which I hadn't earned honestly. If a person wants the award, follow the sponsors rules. If I can't do it honestly, I won't do it at all. If others want to do it unconfirmed, why not? If QSL's are required, the award will not be accepted. If someone wants to circumvent the rules, they will do it. Including first time around should all be up front confirmed. Individuals who do not follow rules should not be awarded. It can be expensive but no integrity without confirmations. It is good the way it stands now, no change. It would shout loudly, liar liar, to me. It's all based on integrity. It's the perfect answer.

Just declare everyone a winner and no confirmations needed. Just publish your accomplishment yourself.

Keep it the way it is to maintain the integrity. Keep it the old fashioned way.

Let cheaters cheat, they are only fooling themselves. Let us not degrade it's purpose. Lets keep all the honest county hunters honest. Like getting a license without learning the requirements. Little activity on bingo award shows that folks don't care. Log data should be provided only when rquested. Log data only required after 2nd time award.

Make it to easy and people will cheat. Many are started under the original rules. Many tourists attracted to the basic award. May get more involved if we go for no chre's for anything. Mobiles who do not accept relays are selfish and arrogant. My word was good before and is good after.

Need separate category for USA-CA's or SWL's. No confirms after holding 2nd time award. No confirmations should be needed for USA-CA holders. No confirmation after second time is best compromise. No easy and cheap solution. No need for two gold seals on the cliff corne award. No need to tempt potential cheaters. No need to get the FBCA if you do it without confirmations. No need to create a class of better than others. No need to pay for confirmations at all. Normally all awards of significance require confirmation. Not enough activity on FBCA to worry about making changes. Not pursuing award because of expense. Novices and techs are eligible for FBCA under current rules.

Only really serious county hunters are trying for FBCA. Opposed to any confirmation requirements.

People should bear the expense if they want the award. People wanting this award should be pre-

pared to work for it. Personally feel no need for confirmations. Please don't make this a rich man's game.

QSLs are unnecessary for awards. Question credibility of whole program because of CQ's stand.

Real bag of worms without confirmations. Recipient only cheats himself and no one else. Reduction of requirements will diminish value of award. Regarding expenses, what hobby is with expense. Relaxed requirements will cause awards to be meaningless. Removal of confirmation would open up the activity. Req confirmations after 2nd time award is also okay. Require confirmations for 1st time only. Require confirmations until USA-CA award is achieved. Require confirmation as long as other MARAC awards do too. Require confirmation at the basic 1500 level. Require mobiles to submit copies of logs for verification. Requiring confirmation until after 2nd time keeps integrity.

Should not be a requirement after 2nd time award. Should not allow plaques to those that are not confirmed. Should not add degrees of difficulty to the awards. Should not force this burden on others no mind what I do. Should also eliminate confirmations for 2nd time award. Some form of change appears appropriate. Some mobilers are not even logging contacts anymore. Specify which procedure the applicant used. Starting date for non confirmed contacts after publication. Stick to the present requirements. Sure the standards are high.

The postage for FBCA is too much after going for 2nd time. The whole system is based on trust. Then everyone would be happy. This award is too precious to allow for loop holes. This award results from an individuals voluntary efforts. This is really a personal goal. This minimum confirmations requirements keeps the cost down. Those wanting this award will be willing to work for it. Too expensive for those on limited income. Too many contacts claimed in contests with out county name. Too many cards are signed without logs being checked. Too many confirmations is too expensive for most CHers. Too many confirmations is too expensive for most CHers. Too many expect a lot for less. Too much loss of integrity now. Too much paper work and filing. Too much expense if confirmations are required.

Unable to understand the rules of the award. Unconfirmed contacts should be verified on a random basis. USACA holders need confirm 1st 1500 on each of five bands. Use a sampling to verify integrity. Use certificate endorsements as confirmed or log information. Use notarized statement of totals for each band. Using log data would be sufficient.

Very few 'cheaters' have shown up in the past.

V/O confirms should be backed up by other awards. We all know whos active enough to have qualified for award. We are too elite already and don't need special confirmation. We should be able to trust CHers with their word. What is the difference between this award and the CQ award. What will be the next compromise. Whatever the outcome, I will continue to have all confirmed. Who is going to check all these contacts. Why not have hams check logs to provide verification. Will go with either way since many folks prefer that. Will go with either way since many folks prefer that. Will go after FBCA only if confirmations are required. Will go with majority but would like to eliminate cost. Will not apply for any awards after USACA because of the cost. With confirmations on all five bands the award is meaningful With or without confirmations would be fair to everyone. Would like to see totals printed in the road runner. Would like to have seen a 1st, 2nd or 3rd choice on ballot. Would personally prefer no change. Would personally prefer no change.


