Net Operating Tips

When working a mobile and you have additional info to pass along to him, his signal report should be the last part of your transmission, ie. following the other info, so he won't forget his report and have to ask for a repeat before he can acknowledge it. Example: "Roger the 5-9, Ed. Aunt Bea sends her love and Uncle Ed's gout is better. Al got a bike for his birthday. You're 5-7". If you give him his 5-7 first, followed by all that other info, he will probably have to ask for a repeat of the report.

When helping with relays, we should only give the call of the relayed station and abstain from giving any hints on the signal report. A comment like "No, its not a 3-3, he's giving you a better report than that" seems to me to taint the contact with a definite odor Some people question the validity of ANY contacts using relays; while you and I may not agree with that position I think we should be careful about giving any clues about the report.

Can you imagine working all counties five times? That is what this month's County Hunter is in the process of doing right now.

He has been hunting counties for the past 22 years now and shows no signs of slowing down. As with many others, he got started by hearing the net activity and getting interested.

A New Awards Program For The Serious County Hunter

The underlying concept of this proposed award program will probably offend many county hunters but the fact is that county hunting as currently practiced is not much of a challenge. I say this even though it took me 18 years to nail down USA-CA 715. The truth, however, is that my county hunting was an on-again, off-again proposition. Those who have monitored 14.336 MHz for the past 10 years will agree that except for my mobile expeditions, my call was seldom heard on the net. And according to several active county hunters, USA-CA has been achieved several times in less than a year -- I understand the record is six months and 10 days, start to finish. Lets face it, folks, all it takes is persistence. Basically, the key to USA-CA is turning on the rig, tuning it to 14.336 MHz and waiting for the counties to drop by. When it gets down to a dozen or so, maybe a few telephone calls are needed to arrange contacts, but even then those contacts are likely to be on 14.336. That's why I'm proposing a new county hunting award program that requires at least a little effort on the part of county hunters

Following are the key provisions of the new awards. Since I still have to work for a living, and since I will not make any money on the awards, I don't want to waste my time designing certificates and setting up processing procedures unless the county hunting community is genuinely interested in the program. So, please read the following and let me know if you are interested in participating. If, and only if, there is enough interest, I'll go forward with the program. Send your comments (a postal card will do) to me at P.O. Box 2499, Capistrano Beach, CA 92624.

Worked All Counties The Hard Way

- 1. Engage in two-way contacts with licensed amateur radio stations in each of the counties and judicial districts of the United States. Each station may be worked one time only. Thus, if a station is worked mobile or portable in one county, that station may not be worked again in any other county, including the home county. You can use county hunter or any other net contacts, but remember one county per station. This means that you must carefully chose which county to claim for each mobile station you work because once you claim a contact, you cannot every again claim other contacts with that station.
- You must include contacts on each of <u>any</u> five authorized amateur bands each time you apply. A minimum of 10 contacts are required for each band. For example, 460 contacts on 20

meters and 10 each on 160, 75, 10 and 6 meters are acceptable as would be 100 on each of the five bands. At least two modes of transmission must be included each time you apply. A minimum of 25 percent of the claimed contacts must be made on the other mode or modes. All authorized modes are acceptable and the 25 percent other-mode-minimum can be satisfied with any combination of modes. For example, 375 single sideband contacts and 125 CW or 75 CW, 25 RTTY, 15 facsimile, 1 ATV and 9 slow scan contacts would be acceptable. The only requirement is that all be direct contacts made without the use of repeaters or digipeaters. However, satellite and earth-moonearth contacts will be accepted.

- 3. At least 1000 counties must be claimed for the initial application, but the initial application can be for any greater number. Your certificate will indicate the number of counties worked. Each subsequent application (except the last to finish up) must include at least 500 additional counties, but these too may contain any greater number of counties. Each application will yield a new certificate showing the new total of counties worked (I don't have the time or money to get involved in seals and ribbons).
- 4. A unique serial number will be issued for each certificate, but since the actual number of counties claimed on each application will vary, separate lists of numbers for each level of achievement will <u>not</u> be kept. However, a separate list of numbers will be kept for the final worked all counties certificate.
- 5. Confirmations are <u>not</u> required, but the certificate wording will indicate whether or not confirmations exist. Certificates for those applying <u>without</u> conformations will contain the phrase "...has claimed contacts with amateur radio stations in XXX counties..." Certificates for those applying <u>with</u> conformations will contain the phrase "...has confirmed contacts with amateur radio stations in XXX counties..."
- 6. Since it will probably take a while for all 3076 counties to be worked under these rules, a box score that lists the number of counties claimed or confirmed by the top county hunters will appear in the Road Runner at least once every three months.

Bingo The Hard Way

1. Engage in two-way contacts with licensed amateur radio stations in each of the counties and judicial districts of the United States. The <u>first letter</u> of each station's suffix must be the <u>first letter</u> of the county claimed. If the county name consists of two words, the <u>first two</u> letters of the suffix must be the <u>first letter of each of the two words in the same sequence.</u> For example, N6SDB is acceptable for San Diego county, but N6BSD is not acceptable. The same sequential rule applies to counties with three-word names. For example, W6SLO is acceptable for San Luis Obispo county, but W6LOS is not. For Alaska, the suffix must follow the district but the call sign's

number may be used. For example, both KL7FJD and N1JDQ are acceptable for the First Judicial District. For the few counties with four-word names, the suffix must match the <u>first three words</u> of the county name. For example, KA0LOT is acceptable for Lake Of The Woods county, but KA0OTW is not.

2. The letter "X" may be used as a wildcard PROVIDED the sequence rules stated in Rule 1 are followed. For example, KB5EXR is acceptable for East Baton Rouge, but W5ERX is not.

There are no other wildcards allowed. Contacts with a station having a USA-CA number <u>cannot</u> be substituted for the required suffix sequence.

 Most of the rules for the Worked All Counties the Hard Way Award apply for this award as well. However, the multi-hand and multi-mode requirements of that award do not apply for this award

The fee for these awards has not yet been determined, but it will be the minimum required to cover my costs. Since each certificate will be printed "to order" on my laser printer, the majority of the cost will be postage and envelopes. Most likely it will be in the \$1 to \$1.25 range.

Well folks, there you have the basics of my proposed awards program. Yes, it will be much harder to finish up the new awards than it is for the current awards, but that's why they're called "...The Hard Way." Even if you're not interested in participating yourself, I think you'll agree that working them all this way is a real achievement in which one can take great pride.

Dateline CW

What a county hunter convention we had in St. Paul, MN. They came from afar and wide and some were. By car, van, truck, motor home and motorcycle. They turned off McKnight Road into the parking lot of the Convention Motel, and ran to the hospitality room. Meeting those at the other end of a CW signal is always excitement at its best. Ever notice the person is always different from the mental image concocted from their CW signal, even those you met at the last convention seemed more mature. I pray everyone had a safe trip home. Minutes Of The MARAC September Meeting

The meeting was held on Sept 7, 1991 at the Holiday Inn East, St. Paul, MN. President Don, WAOLKL, called the meeting to order at 9 AM. Also in attendance were WOKHM, W9LHG, WAORJI, KWOU, NODXH, and NODRX.

W0KMH moved that the Secretary's report be accepted, second by N0DXH, motion carried.

W0FCO moved that the Treasurer's report be accepted, second by WA0RJJ, motion carried.

Vern, WAORJJ, reported for the Capital Equipment Improvement Committee, that a computer package has been purchased for \$1,937.53. The package includes a used 1 1/2 year old IBM PS/2 Model 55 SX 031 computer, 30 mHz hard drive, and 3.5 inch diskette drive. As this machine did not have a 5 1/4 inch disk drive, a new one and associated hardware have been ordered and are included in the above cost. If purchased new, the hardware in this package would cost about \$4,300 today.

NODRX presented a report on postage meters. WAORIJ moved that NODRX proceed and obtain a postage meter for the Awards Custodian, second by W9LHG, motion carried.

WAOLKL conducted an "open mailbag" session where letters intended to be, are discussed. There are some good ideas in there that will likely be considered and appear in some form in future Secretary's minutes.

From the "open mailbag", N0DR X moved to accept a proposal to hold the 1993 National MARAC convention in Seattle, WA., second by N0DRX, motion carried.

The Secretary reported that we have received notification from the ARRL that our application for club affiliation has been approved. This allows MARAC to be eligible to apply for club liability insurance through the ARRL program. NODRX will be taking care of the paperwork.

Motion to adjourn was made by W9LHG, second by N0DXH, motion carried.

ARRI Affiliation Achieved

As noted in the Secretary's minutes, MARAC is now an affiliated club with the ARRL. This affiliation must be recertificated annually and requires that a minimum of 51% of our members also be members of the ARRL.

What MARAC offers to the ARRL is a fairly large base of very active radio operators with the common interest in working counties, but many of us have other interests in amateur radio as well. Obviously at least 51% of our members already are ARRL members, or we would not have qualified for club affiliation.

ARRL affiliation allows MARAC to be eligible to apply for club liability insurance through the ARRL program. We were unable to obtain affordable insurance independently and feel it essential to protect the club and the people who convene our conventions.

Another benefit is financial. For each ARRL renewal membership processed through MARAC, we can retain a \$2 fee and for each new ARRL membership a \$5 fee. I would encourage that anyone wishing to renew ARRL membership, or become anew ARRL member, send those checks to me made out to MARAC for the amount you would normally send to the ARRL. Make a note in the memo portion of the check that it is for ARRL membership and include any renewal notice, etc., that you would normally send to the ARRL. I have ARRL applications and will be glad to send them out on request with an \$ASE.

Ballot Results

I wish to thank everyone who exercised their privilege to vote on the confirmation issue. Would have liked to have seen every eligible member vote, but that happens only in fairy tales. Of the ballots received, 8 are not included in the final YES or NO tally; one of them was totally blank, four of them indicated a desire to vote, but had no call sign, MARAC No., or name. As I could not verify voter eligibility, they were not counted, the other three ballots were plainly marked as wishing to abstain or not vote either Yes or No, for reasons of impartiality, or not wanting awards issued with the letter "N" on them for non-confirmed contacts.

The results of 369 valid ballots are:

YES: 199

NO: 167

ABSTENTIONS: 3

Effective October 1, 1991, the MARAC First and Second "Time Awards will continue to require confirmed contacts. ALL other MARAC Awards will have the OPTION of confirmed or non-confirmed contacts. Awards will note an "N" for non-confirmed.

Anyone not wishing to have the "n" on their award may continue to confirm contacts as before and apply for the award as confirmed.

If you have to report an emergency in New York please be aware that there are small green signs located every 1/4 mile along most roads bigger than cow paths. They contain three rows of numbers, the first row being the route number.



Just report these numbers and they will know exactly where you are. With a sign every 1/4 mile you are not likely to be very far from a sign. I have seen such signs in VT and other NE states, but slightly farther apart.

County Hunter Computer Program Update

I very much appreciate all the feedback from a number of County Hunters who are using the COUNTY program on ways to improve performance and the identification of a number of bugs which have now been corrected.

In addition to the program features outlined in the May edition of the Countyline roadrunner, the following fetures have been added:

- $1. \ Accumulated time spent as \ New \ Control \ with \ the \ time \\ on \ and \ off \ noted \ in \ the \ station \ file.$
- 2. Counties remaining to be worked for mobile to mobile contacts.
- 3. A listing of mobile contacts/counties provided to specified4. A listing of overdue MRC's.
- 5. A hard copy listing of counties remaining to be worked when there are less than 75 to go.
- The program is now compiled using Clipper 5.0 rather than an earlier version of CLipper with a considerable increase in operating speed.

The program is available free of charge to those who want to use it. Anyone who currently has a version earlier than V3.10 may want to upgrade (the version is noted on the label of the disk I sent you - if there is no number on the label then you certainly should get a new copy.

Mobile Hints

While taking the old system apart and restoring it in a new vehicle, I came across a problem that may be worth passing on. I have not enjoyed a good signal receive or transmit the last 6 to 8 months...or certainly not like it was when installed.

After going over the rig...all FB, I looked at the antenna and just could not seem to "cure it". While doing recent work, I took the ball at the base of the antenna apart (am using the 2" Hustler) and found the bolt head of the center bolt was just about rusted away! Now this is about a 3/4" head and the water line on the inside of the ball shows that water was present for some time now! If any members find a deteriorating signal problem, they may want to examine their antenna too and may find the same problem. In my case, it was so far shot that it had to be replaced, not repaired.

Because of all the computer/RFI components involved, I decided to install a 1/2" copper tube channel for the power lines from the battery thru the firewall, and have grounded it to the chassis. Will let you know how this works out. KA3DRO.

Alternator Noise Suppressor

Following is a simple and easy way to protect the suppressor from the engine compartment environment, and provide a neat appearance also. The 4-ohm resistor and 0.002 uf capacitor, series connected as suggested in the ARRL Mobile Manual is encapsulated by the use of a hot glue gun, an item which is in prominence these days.

This filter works every bit as well as a commercially built unit did before it fell apart. My suppressor has not failed to work in weather where the temperature has dropped to -10 F, nor has the glue come apart.

Mobile Burglar Alarm

To protect your equipment from theft, try mounting a normally closed push button switch behind the equipment. When the equipment is installed, the switch is open and is connected in parallel with the car horn button, so that if the equipment is removed, the spring return push button will

complete the horn circuit and discourage the thief from any further tampering.

Mag Mount Surface Maintenance

Although magnetic antenna mounts are intended to serve as temporary antenna supports, many use them for permanent installations. As a result, stories of mag mounted related paint damage abound. You can minimize such damage and, with a little care, keep the paint beneath a mag mount free of scratches for many years.

First, prepare the mounting surface by wiping any grit away with a damp cloth or soft rag. Wipe it again with your hand. (Your sense of touch may be able to detect small, sharp particles that might be present.) Nest, apply a coat of clear, hard automobile wax to the mounting surface.

Wipe the waxed mounting surface as just described. Check the bottom of the mount to ensure that metal filings or anything that might scratch your car's paint hasn't been trapped by the mount magnet or under the magnet's protective surface coating. If in doubt, clean the bottom of the mount, and clean the waxed mounting surface again. Install the mount.

Wipe the mount and mounting surface regularly (daily, weekly, depending on how dusty or dirty your commute is.) This lessens the chance of grit getting trapped under the magnet and scratching the surface from normal vibration Clean the mount and mounting surface as soon as possible after driving through a dusty or sandy region, or on roads used by sand or gravel trucks.

Don't rotate the mount when removing it from the car. Force it straight up from the car by its edge. This reduces the lapping wheel effect that occurs if you rotate the mount to remove it.
