Net Operating Tips By Mitch, W4RKV

All of us are aware that under FCC rues no one amateur, or group of amateurs, may claim the exclusive use of any frequency however, once established on an unused frequency we have the right to its use reasonably free of adjacent channel ORM. But in today's crowded bands, the term "reasonable" should not be construed to mean "clear channel" where no other station should get within 5 kHz of

The current state-of-the-art seems to dictate a bandwidth of about 2.1 kHz for SSB voice communications, and that is the general rule of thumb I use when acting as NCS. If another station starts up on 14.334 or 14.338 and is strongly interfering with me, I may go and REQUEST that if possible he move a little farther away. But as long as he is 2 kHz (or more) away, I don't feel I have the right to DE-MAND that he move. If he is buck shotting or otherwise overmadulating, I may request that he turn his mike gain down a little, or perhaps turn his amp off, but I will always put it in the form of a request and abstain from making any demands.

Members Speak!

KA3DRO, Ron -- In recent conversation in MMM Convention I discussed this county (see photo) with W0FF. He knew of it having lived in area some years back. It is located at Gates NC, line with VA Isle of Wight.



At any rate, I thought some of the county hunters may like to see the sign as the county is no longer there. From info on the sign it has evolved through three other name changes. Question becomes--has any other county changed names so often?

K4ELK, Walt--It is generally recognized that as a person ages certain organic changes occur. The hair turns grey (usually), the hose and ears continue to grow, etc. What does not seem to be recognized is the medically accepted fact that in the aging process the ability to distinguish consonants is diminished or even lost. For that reason it is useless to tell us older types to be more alert, listen harder or whatever. If we are familiar with

your call there is no problem but if we are not and it contains some consonants we will probably get is wrong (of course, some young people have this problem also). And as Mitch suggested recently in the Roadrunner only standard phonetics should be used. The use of non-standard "cute" phonetics just causes confusion. Of the two more or less standard ones, the ABLE, BAKER set is the faster but the ALPHA, BRAVO is better recognized worldwide and better overcomes accent problems.

KC3QC, Geoff -- Recently, being "between jobs" thanks to the current economic climate, I have had the opportunity of checking in on the 14.336 net during the daytime. I find it very disturbing when a Net Control says he has to QRX and asks for someone to take over, and no one will! He has been running a very active net for many hours with a large number of fixed stations collecting counties, but no one wants to help out. Why?

I know there are many reasons, and they may not always be obvious. TVI could be one factor, the lack of time another, but the latter cannot be claimed by someone who has sat on the net all day long. Another reason may be associated with the less fortunate, who may suffer some disability. However, the most "popular" disinclination may be due to the operator feeling just plain scared to take it on. I was very apprehensive the first time I tried, but it really wasn't that bad. I got fixed helpers in TX and CA, and all the mobiles running helped in their own way. I want to tell you, I felt good after that first time, I may have messed up a few times, but it saved the net from the dreaded works "the net is in open session!"

I accept that there has been criticism because a net has not been run properly according to some, but allowances should always be made for the reason. In any case, where else can the experience be gained? Only by mistakes can perfection be achieved! To those who criticize I say "Show me how it should be done!"


Nevertheless, there is no need whatsoever to be worried because you may have been "lumbered". Better to take advantage of the power that you have assumed and show that you in CONTROL. It is very unlikely you would be able to wield such power elsewhere in your own household as you do behind the closed doors of your shack, especially if you are out of earshot. Joking apart, some large nets have been controlled in a very expert manner by someone new to it. This should give some encouragement to those who tend to reap all the benefits without "paying their dues".

In county hunting we should all play a part, the mobles certainly put extraordinary amounts of time and money into it. As a fixed station, interested in getting your certificate, what do you give? Think back to the last time you heard that deadly silence following a plea from a controller who has to go. It is truly amazing how many people suddenly acquire that same need to go. Usually someone takes over, but it;s the same ones most

of the time. Give a thought for the mobiles who may be hanging around waiting for help. After all they re listening, and waiting. It is not very encouraging for them is it? They must feel that the efforts they are giving is a little one sided, and not being reciprocated. I hope in the future that I can take a more active part in helping all of us to enjoy our quest for the elusive certificate, but to all fixed stations I say; "Let's avoid the words the net is in open session, even if you can only help for a short time."

Mobile Burglar Alarm

The circuit below is an inexpensive, simple, yet effective alarm for protecting against theft of mobile equipment including the mobile. When "S1" is closed to the "ready" position, the alarm is armed and opening any of the car doors, hood or trunk or anything protected by "S2..." will actuate the car horn, which will give an audible alert. The horn will continue to blow, even if the door, etc, is closed. "S1" is a key switch and should be located at any convenient spot on the outside of the car. Mercury-type switches could be used on the hood and trunk. Once the system is activated, it can be stopped only by the opening of "S1".

1992 MARAC SSB COUNTY HUNTERS' CONTEST

0000z Saturday April 11 to 2400z Sunday April 12, 1992

The Mobile Amateur Radio Awards Club is pleased to sponsor the 21st Annual County Hunters' SSB Contest. Mobile and fixed operation from every county in the U.S. is welcomed, and operation from less active counties is encouraged. Fixed stations may be worked only once on each band. Mobiles may be worked each time they change counties. Mobiles operating on county lines count as one contact, but each county may be a separate multiplier. (Mobiles must identify by signing /M after their call.) To be eligible for an award, a station must not operate more than one transmitter at any one time.

EXCHANGE: Signal Rpt, County & State for U.S., Province or Country for others.

SCORING: QSOs with fixed US/Canadian stations are worth 1 point; mobiles are worth 15 points. US/Canadian contacts with DX are worth 5 points. Contacts with stations operating under a "net control" are invalid for contest purposes. FINAL SCORE = total QSO points times (X) total number of U.S. counties worked.

FREQUENCIES: 3.880, 7.240, 14.270, 21.340, 28.340 mHz. Fixed stations should work above the suggested frequencies and allow low power mobiles to operate below the suggested frequencies.

AWARDS: Certificates to winning stations as follows:

- Fixed stn in each state, province, and country with 1,000+ points
- Mobile in each state operating in 3 or more counties with a minimum of 10 contacts from each county

MARAC plaque to 1st & 2nd place mobile in the U.S., highest scoring North American fixed station, and highest scoring DX station scoring at least 50,000 points.

Mobiles who change states should calculate their scores (1) for individual state certificates and (2) for total score for the overall plaque. Total overall score must not count a county as a multiplier more than once regardless of the location or frequency.

A check sheet of counties is required for entries with 100 or more counties worked. Completed logs, summary sheets, and check sheets must be received by May 12, 1992 to Barry Brewer, WA5DTK, 5518 12th Street, Lubbock, Texas 79416.

CONTEST PERIOD: CW - 1200Z, Feb. 22 to 2400Z Feb. 23, 1992

SSB - 1200Z, Feb. 29 to 2400Z Mar. 1, 1992

FREQUENCIES: CW - 28.150 - 28.300 CW Mobile Window - 28.155 - 28.165

SSB - 28.330 - 28.500 SSB Mobile Window - 28.340 - 28.400

Mobile stations will be calling within these windows and fixed stations are asked to refrain from calling "CQ" within these windows. After making Mobile contacts within the Mobile window, fixed stations should QSY outside the window to work other fixed stations. CW-OPS: QSO Part is in the 10 Meter Novice Sub-Band; please QRS when necessary.

CATEGORIES: Only single operator mobile or fixed stations are eligible. One person must perform all operating, logging, and spotting functions.

EXCHANGE: Signal report, station designator (F for Fixed, M for Mobile) and location (US County, Canadian province or DX country).

SCORING: Final Score = Multiplier X Contact Points.

Multiplier = Total number of US counties, Canadian provinces and DX countries. (US and

Canada excluded)

Contact = 10 for each contact with a mobile Points = 1 for each contact with a fixed station

MISCELLANEOUS RULES:

1. A mobile may be worked in each county, province or DX country it travels through.

2. Mobiles on county, province or country borders count as one contact (10 contact points) and 2 multipliers.

3. Fixed stations may work other fixed stations only once for scoring credit.

4. No net, prearranged or repeater contacts will count for scoring.

5. No relayed information or assistance will be allowed from valid contacts.

6. Portable stations follow fixed station rules for scoring.

7. A station signing mobile must be capable at all times in the contest period of transmitting and receiving in motion with no connections to stationary power lines, generators, antennas or other objects.

8. Remote control is not allowed.

LOGGING DATA REQUIRED: Date - Time (2) - Station worked w/designator (M or F) - Report exchanged (Min. acceptable report = 2X2) - County & State (Province for Canadian stations & Country for DX stations) - Claimed points - Multipliers (each new county, province or country must be consecutively numbered in the log.

SUBMISSIONS: Every station must submit a complete log. Duplicate contacts may remain in log as long as they are marked as DUPE and not used in scoring. All logs must be on 8½" X 11" paper. Legible computer printouts are acceptable. A check log would be appreciated. Novice / Tech. stations must identify themselves as such to claim any award. Blank logs (3), summary sheet and info are available for a #10 SASE with two 29 cent postage stamps to:

INSTALLATION GUIDELINE

(refer to the enclosed figures during installation)

1. Transmitter Location

- A. Locate transceiver for remote radios on driver's side of trunk as near to the vehicle body side as possible.
- B. One piece transceivers should be mounted under dash or on transmission hump where they will not interfere with vehicle controls or passenger movement.

2. Antenna Installation

- A. The antenna should be a permanent-mount type located in the center of the roof or center of the rear deck lid. Glass mounted antennas should be kept as high as possible in the center of the rear window or windshield. If a magnetic-mount antenna must be used, care should be taken to mount the antenna in the same location as a permanent mount type. If a disguise-mount antenna is used, great care should be taken to shield the tuning network from vehicle electronics and wiring, or to mount the tuning network in an area completely clear of vehicle electronics and wiring.
- B. Each vehicle model and body style reacts to radio frequency energy differently. When dealing with an unfamiliar vehicle, it is suggested that a magnetic-mount antenna be used to check the proposed antenna location for unwanted effects on the vehicle. Antenna location is a major factor in these effects.

3. Antenna Cable Routing

- A. Always use a high quality coax (at least 95% shield coverage) routed away from the Engine Control Module (ECM) and other electronics modules
- B. Care should be taken to avoid routing feedline with any vehicle wiring.

4. Antenna Tuning

 A. It is important that the antenna be tuned properly and reflected power be kept to a minimum. (VSWR < 2:1)

5. Radio Wiring and Connection Locations

A. Transceiver Power Leads:

These connections should be made directly to the battery itself, including the ground, or to the jump start block on vehicles so equipped. The transceiver power feeds should be #10 AWG wire or larger, twisted if possible. The ground wire should not be attached to the body at any point. Appropriate in-line fuses for both the positive and ground leads should be located as near the battery as possible.

NOTE:

It is recommended that a fuse be placed in the transceiver ground lead to prevent possible damage to the transceiver, in the event the battery to engine-block ground is inadvertently disconnected.

For ONE-PIECE TRANSCEIVERS where ignition switch control is desired, a 12 v power contactor must be installed in the transceiver positive lead. The contactor should be located at the vehicle battery with the coil of the contactor driven through an appropriate in-line fuse from an available accessory circuit or ignition circuit not powered during cranking. The coil of the contactor must return to battery negative.

- B. Handset or Control Unit Battery and Ground:
- Any ground lead from a handset or control unit must return to battery negative. It is preferable that the positive lead for a handset or control unit be connected directly to the battery. It is recommended that the handset or control unit positive and ground leads be appropriately fused separately from the transcelver positive and ground leads. If ignition switch control is desired, the handset or control unit positive lead may be connected through an appropriate in-line fuse to an available accessory circuit or ignition circuit not powered during cranking.
- C. Connections for Multiple Transceivers and Receivers: If multiple transceivers or receivers are to be installed in the vehicle, power leads to the trunk or under dash should be terminated in covered insulated buss bars. All transceivers or receivers may then have their power leads connected to the buss bars. This makes a neater installation and reduces the number of wires running to vehicle underhood.

6. Wire Routing

- A. The power leads should be brought through a grommet on the driver's side firewall. For trunk-mounted transceivers, the cables should continue on along the driver's side door sills, under the rear seat, and into the trunk through the rear bulkhead. If the battery is located on the passenger side, battery leads should cross the vehicle in front of the engine. All attempts should be made to maintain as much distance as possible between radio power leads and vehicle electronic modules and wiring.
- B. For police vehicles, radio power leads should be routed in the conduit provided with the option package.

7. Troubleshooting

- Should vehicle problems develop following installation, the source of the problem should be determined prior to further operation of the vehicle.
- B. Possible causes of vehicle problems include:
 - Power feeds connected to points other than the battery.
 - 2. Antenna location.
 - Transceiver wiring located too close to vehicle electronic modules or wiring.
 - 4. Poor shielding or poor connectors on antenna feedline.

8. Contact and Feedback

A. GM vehicles have been designed and extensively tested for immunity to known sources of RF energy. However, it is impossible to test for every combination of RF sources and installations. If a persistent condition is encountered,




