Net Operating Tips By Mitch, W4RKV

The name of the game in county hunting is to work the mobiles direct if at all possible and thereby avoid time consuming relays, without making an honest effort to make direct contact. It gets a little aggravating after a while to have to keep relaying in the same station time after time (when you know they didn't call during the mobile's run), only to have them send the mobile a 5-5 or better. Since a 5-anything by definition is "perfectly readable", why didn't the station try and make contact during the regular run? If only a latecomer, why not wait and work the mobile direct on his last call?

Speaking of relays, have you noticed how often a "direct" will call in on the very first call for relays, this after repeated QRZ's from the mobile elicited no calls? My feeling on this is that the "direct" had his chance to work the mobile during the regular run, and now I should help those who genuinely need a relay and have been patiently(?) waiting. The "direct" can then make contact on the mobile's last call, time permitting.

A final suggestion on relays: when helping the mobile with relays, it is much quicker to take a list rather than acknowledge the calls singly, as in "W9ABC got you, who else needs a relay". Why not just say you'll take a list of relays, copy down what you hear, then feed them in one after the other? The most time consuming of all is to solicit and relay in the calls one by one, as in "W8DEF go to the mobile: (reports are exchanged), then "That's a good one, who else needs a relay for XYZ, NV?" and on and on.

As the new year rings in the Awards Program is fully up and running and most of the problems encountered have been solved at this end, but we are all subject to make mistakes and I will try to be tolerant of yours as I ask you to be of mine.

I AM PLEASED TO ANNOUNCE THE FOLLOWING NEW SECOND TIME AROUND HOLDERS:

In the past there has been much confusion concerning the "Mobile" Awards, Categories 1 thru 4, so I will try to clear that up now; Category 1 and 3 are for TRANSMITTING (Putting out, giving, etc) as a MOBILE from STATES(CAT 1), COUNTIES(CAT 3), Category 2 and 4 are for WORKING THE SAME MOBILE in STATES (CAT 2) and COUNTIES (CAT 4).

Ex: K4QFK works N9DEH in 500 counties; K4QFK would apply for a CAT 4 award for himself for WORKING N9DEH in 500 counties and if he wanted to send the mobile an award for these contacts, He would apply for a CAT 3 award for N9DEH for TRANSMITTING 500 counties to K4QFK. Part of the confusion has resulted from the "wording" in the awards information packet, this has now been changed.

One other problem with the MOBILE Awards is when they are up-graded; Since in the past the WRONG CATEGORY has been applied for AND ISSUED, when you apply for an upgrade, the original award will be up-graded as issued, I cannot correct all of these errors from the past. Another problem is the NUMBER of the award that you are requesting to be up-graded, If you originally applied for the award AND applied for an award for the MOBILE, your number and the mobiles number will NOT BE THE SAME, but should be logged in as the number before or after yours (Or Close) so that if you are also applying for the upgrade for the mobile I will be able to look it up for you.

The COSTS of Awards seems to be another issue, so we will recap that; The BASIC cost of all Awards is \$2.00 for MARAC members and \$3.00 for Non-members (If you are a QSL Manager for another station and HE/SHE is NOT a member the cost is \$3.00) (Certificates), The MARAC "Car" Plaque is \$20.00, and \$30.00 for Non-members, The large Plaque is \$40.00, and \$50.00 for Non-members.

The cost for the FIVE BAND COUNTIES AWARD is \$10.00 for the basic award, \$20.00 for Non-members, WHEN APPLYING FOR ANY PLAQUE, THERE IS NO ADDITIONAL CHARGE FOR THE ACCOMPANYING

CERTIFICATE. There is NO Charge for up-grading the Awards(Seals)

For Awards that require a "LIST" you may use any of the "Books" currently available, such as CQ, Mobile QSL Bureau, B&B Shop, etc., OR A Computer Print-out as long as the Counties are in Alphabetical Order by State and entries contain the basic information required. When sumitting for the 2nd time award and the book you are using does not contain a "Certification" statement such as the CQ book, or you are submitting a computer print-out, you must "type" or "copy" such statement and attach it to the book or print-out.

If you are applying for any of the MARAC Awards and do not have a copy of The Awards Information Packet, I will send you one for a business size sase with 2 units of postage, (currently 52 cents). Please send a BUSINESS SIZE SASE When requesting any INFO or Forms. If you are requesting Application forms, except LC-1,2 and 3, I can send 4 for one unit of postage, LC slips (12).

SOME TIPS WHEN FILLING OUT THE LC SLIPS: Whether you are using the Old or New slips, Please fill out ONLY the upper LEFT part of the slip, If you want to say something "personal" on the STUB, use ONLY the Address section at the top. Information in the wrong place will be "over-typed" by the printer and made illegible. LC Awards are from YOU and to the MOBILE. "The Last County for the whole USA", whatever the reason, is an LC-2 Award and because it also happens to be the last county for one of the States does not constitute another LC-1 Award.

I have received a few awards applications with less than the proper amount, I have processed these and sent you a slip requesting the additional funds, I will not return awards applications unless this is repeated. I have also received many applications with too much money and have notified you of such, If there is a reason for these additional funds, Please state the purpose.

POLICY REGARDING LAST COUNTY AWARDS THAT YOU APPLY AND PAY FOR ON BEHALF OF YOURSELF: Last County applications received FOR you BY you must be accompanied by one of the following; An LC Application slip filled out and SIGNED by the person that you gave the last county to, OR, A copy of the MRC that you signed plainly stating that it was for the Last County, OR, QSL Card which states that the contact was for the Last county and lists that county. ANY OF THESE REQUESTS SHOULD NOT BE MADE UNTIL YOU KNOW THAT THE STATION IS NOT SUBMITTING FOR THE AWARD OR A GREAT AMOUNT OF TIME HAS PASSED. Any such requests will be checked in the Data Base for duplication. I would like to suggest to stations who do not plan to give last county awards for whatever reason, (Some people cannot afford them, or only give them out for the first time around, etc) That you send a "Filled out and Signed" LC slip to the Mobile to at least afford him the opportunity to apply for the award.

AWARDS COMMITTEE: As of this writing I have not received a nomination from every district for a awards committee representative so the Committee will consist of those that I do have at present:

If you have any questions about the awards program, not related to processing of the awards, or suggestions for changes, etc. Contact the Awards representative in your district or your District Director. (In some cases this is the same person).

I have imposed only one Mandate on the Awards Committee and that is that ANY Changes made to the Awards Program other than Administrative matters will be decided on by the Members of MARAC after such proposals have been published this Newsletter. Administrative changes such as the increasing of and adding levels to already existing awards will be decided by the Awards Committee as a whole. I feel that this Committee will fairly represent the Members of MARAC, I did not pick them because I do not want them to represent me. We will do our best for the Membership but I doubt that we will obtain perfection.

During the first Month (Actually five weeks) which included my training session and help from Bill, W0OWY, we processed a total of 1,015 Awards. Thank You for your Patience and allowing me to "catch up". I expect to be a little "quicker" after the second month.

quality of his life, and helped him visit the world through their eyes.


Thank You

WU4S, Stu --I would like to thank all of you that helped me work all counties the 2nd Time. If I worked you in a Last County and you have not received credit (and you want it) please let me know. I have submitted to K4QFK all the Cat 1 awards. Again, Thank you.

WOUBT, Bud -- The end is in sight to complete my USA-CA (1st Time). Only about 100 more counties have to be worked and confirmed. The vast majority within a 500 mile radius of my home here in MN...typical when all of my contacts, except for a few, have been on the 20 meter net.

My main purpose in writing is to tell all of you to NOT repeat NOT give me any "one ringers". The reason is as follows: Because I have been deluged with "nuisance" calls of late, I have installed a Telephone Call Screener in my telephone line...plugging my telephone into my screener. A three (3) digit "access code" has to touch-toned in by my caller before my telephone will ring. Only my immediate family, and a very few others, have been apprised of that code. I'm very sorry about the situation but that is the way it has to be...at least for now...trust me. Please pass the word, thank you.

WA2AKB, Aaron --I'm sorry to report that all MRC's, QSL's etc sent to my home from the Mobile QSL Bureau on or about October 27, 1992 were lost in the mail. Hopefully the various stations will re-submit their cards if they see this notice. I am new at county hunting so every possible confirmation is critical. Also, will each of you PLEASE send me your personal QSL for first time contacts. I enjoy taking special trips to give out the majority of NY state and surrounding counties, weather and time permitting.

KB3GN, George -- I believe that the original concept was to foster a sense of "togetherness" and the chance to say "thank

you" for all the counties the mobiles give out. Also, it was to provide the mobile operator with the opportunity to use fixed stations as contacts towards the USA-CA Award. There are now other awards that have become available which also require many contacts, like the Five Band and Five Star. These are infinitely more challenging to us all. Again, mobile contacts do provide an additional source to accomplish these goals as do fixed station contacts.

As a "take 'em whenever you can get 'em" operator who rarely gets time to operate as a fixed station, but loves to put out counties, my point of view is the "FIRST TIME" contact is not limited to once. I consider "FIRST TIME" to mean first time each band, first time since I got my number, first time since you got "THIRD TIME" or even first time since your sex change operation. There are a lot of awards out there so PLEASE ease the mobiles work load and send a QSL card with your county and your STAR info on it along with your MRC's.

KC9EU < Rich — I thought I was the only one who did not receive signed MRC's from mobiles. From other letters to Members Speak!", I find that is not so. There are several of us that cannot understand why mobiles bother to run counties if they do not return cards. I wish somebody—either the Road Runner or the Mobile QSL Bureau would list the mobiles who do not sign MRC's for one reason or another. In June, 1992, the Mobile QSL Bureau listed 11 different reasons why mobiles do not sign MRC's — I would like to know who those mobiles are so that I would not bother to send cards to them anymore.

One of the reasons listed is because there MRC contained only one contact! I am getting close to "Last County" in several states, and sometimes I need only that one contact, so I send the MRC hoping that mobiler isn't one of those who do not sign because of a single contact.


Some mobiles want the entire card filled up! If the above mobiler is running in several counties, counties that I already have QSL'ed and I need only one, it is a waste of my time, his/her time, and the time of other county hunters to make contacts in counties I do not need.

And the list goes on.

n front of me, I have a list of 16 mobiles to whom I have sent a QSL card, a MRC card and a SASE and have not heard from them. The contacts go back to November, 1991! Many of the MRC's haver multiple contacts,, so it really frustrates me thinking that perhaps these people are those that do not sign cards for one reason or another — it's especially frustrating knowing I need those counties — and it's frustrating knowing I wasted money. What do those people do with my SASE?

Like I said, I wish I had a list of those mobiles who do not sign cards. I wouldn't waste time,or money if I heard them on the air, even though I needed the county! In desperation, I have reworked some of the counties and now have them QSL,ed Thanks to those mobiles who promptly sign and return MRC's.

KOAYO, Bob — QRZ Mobiles, DX, AND QRP stations AND Close in (350 miles) stations. It is very frustrating it hear a mobile within 200 - 300 miles of you, ten minutes is up and the mobile gets the word to call for "Mobiles and DX" and a DX station comes back with a 33, or 55 both ways. It was easier for them to work the mobile then is was for the "close in" station who REALLY depends on unique band conditions to hear and be heard. Go to 40 you say! Great and I do if I can BUT that still doesn't "fill in that 20 meter band missing county". I believe that if the mobile runs out of time, limit him/her to "Mobiles Only" since they are so important to our endeavors, but do not discriminate us "close in or QRP NON-DX stations".

Excerpt From "QST"

NN8R, Ray Grob, of Fremont OH recently wrote in to pass along his comments regarding the "...long past time when our archaic and meaningless system of signal reports should..change..". He proposes a scale of 1 to 3, Unreadable, readable with difficulty of fully readable; weak, fair or strong.

That would really speed things up on the net since the rules say, nothing less then a 2 x 2 report is acceptable. There could be no more complaints about " the ridiculous 2 x 2 guessing game" going on all the time. Everyone could honestly say "2 x 2 or 3 x 3"; that is if you really heard the station 3 X 3 and if you didn't you could say 2 X 2 and no one would think you might be guessing!

What do you think of THAT?

USA-CA RULES AND PROGRAM

The United States of America Counties Award sponsored by CQ is issued for confirmed two way radio contacts with specified numbers of U.S. counties under Rules and conditions hereafter stated (as of January 1, 1993).

A. Awards Classes:

The USA-CA is issued in seven (7) different classes, each a separate achievement as endorsed on the basic certificate by use of special seals for higher class. Also, special endorsements will be made for all one band or mode operations subject to the rules.

B. Conditions:

1. USA-CA is available to all licensed amateurs everywhere in the world and is issued to them as individuals for all county contacts made, regardless of calls held, operating QTHs, or dates.

Special USA-CA's also available to s.w.l.'s on a heard basis.

- 2. All contacts must be confirmed by QSL and such QSLs must be in one's possession for identification by certification officials.
- 3. Any QSL card found to be altered in any way disqualifies applicant.
- 4. QSOs via repeaters, satellites, moon bounce, and phone patches are NOT valid for USA-CA.
- 5. So-called "team" contacts, wherein one person acknowledges a signal report and another returns a signal report, while both amateur call signs are logged, are NOT valid for USA-CA. Acceptable contact can be made with only one station at a time.

C. County Identity

1. Unless otherwise indicated on QSL cards, the QTH printed on cards will determine county identity.

2. The National Zip Code & Directory of Post Offices will be helpful in some cases in determining identity of counties of contact as ascertained by name of nearest municipality. Publication No. 65 is available from the Superintendent of Documents. U.S. Government Printing Office, Washington, D.C 20402, Stock No. 039-000-00264-7, shipped only to U.S.A. or Canada.

3. For mobile and portable operations the postmark shall identify the county unless information stated on QSL cards makes other positive identity.

4. In the case of Cities, Parks, or Reservations not within counties, proper, applicants may claim any one of adjoining counties for credit (Once).

D. Administration of USA-CA Program:

1. The USA-CA program will be administered by a CQ staff member acting as USA-CA Custodian, and all applications and related correspondence should be sent directly to him at his QTH.

2. Decisions of the Custodian in administering these Rules and their interpretation including future amendments are final.

E. Record Book and Bookkeeping:

1. The scope of USA-CA makes it mandatory that special Record Books be used for application. For this purpose, CQ has provided a 64-page 41" by 11" Record Book which contains application and certification forms and which provides record-log space meeting the condition of any Class award and/or endorsement requested.

2. A completed USA-CA Record Book constitutes medium of basic application and becomes the property of CQ for record purposes. On subsequent applications for either higher classes or for special endorsements, applicant may use additional Record Books to list required data or may make up own alphabetical lists conforming to requirements.

3. Record Books are to be obtained directly from CQ, 76 N. Broadway, Hicksville, N.Y. 11801 for \$2.00 each. Recommend two be obtained, one for application use and one for personal file copy.

F. Application:

1. Make Record Book entries necessary for county identity and enter other log data necessary to satisfy any special endorsements (band-mode) requested.

2. Have the certification form provided signed by two licensed amateurs (General Class or higher) or an official of a national-level radio organization or affiliated club verifying that QSL cards for all contacts as listed have been seen. The USA-CA Custodian reserves the right to request any specific cards to satisfy any doubt whatever. In such cases applicant should send sufficient postage for return of cards by registered mail.

3. Send original completed Record Book (NOT a copy) and certification forms and handling fee. Fee for nonsubscribers to CQ is \$10.00 U.S. or 40 IRCs; for subsribers the fee is \$4.00 or 12 IRCs. (Subscribers please include recent CQ mailing label.) Send to USA-CA Custodian. Norm Van Raay, WA3RTY, Box 76, Pleasant Mount, PA 18453-0076. For later applications for higher class seals, send Record Book or self-prepared list per rules and \$1.25 or 6 IRCs handling charge. For application for later special endorsements (Band/Mode) where certificates must be returned for endorsement, send certificate and \$1.50 or 8 IRCs for handling charges. Note: At the time any USA-CA award certificate is being processed, there are no charges other than the basic fee, regardless of number of endorsements or seals; likewise, one may skip lower classes of USA-CA and get higher classes without losing any lower awards credits or paying any fee for them. Also Note: IRC's NOT accepted from U.S. stations.
