### **Net Operating Tips** By Mitch, W4RKV

Many of the tips that will appear in this column are referred to, either directly or obliquely, in the County Hunters Handbook (available from the B & B Shop) in the section devoted to Net Operating Procedures. When this is the case, a parenthetical notation will identify the relevant section of the Handbook. The following tip contains an example.

Always remember that TIME on the net is a finite asset, and is particularly valuable during periods of high mobile activity, such as weekends and during convention times. Bear in mind that queries, unless solicited by the NCS, usually interrupt the smooth flow of the net. It only takes a few seconds to answer my query, you say? If each of the several hundred fixed and mobile stations listening to the SSB Net on a busy Saturday afternoon initiated only one query each, how much time would that take? Trivial queries (5.5.10) should be saved for slack periods, or when the NCS asks for them to keep the net frequency active. Weekend afternoons are not the time to interrupt the net to ask who ran Podunk county five weeks ago. (More on trivial queries next month).

# High and Low Points from the Seattle trip. By C. K. Walter, AD0H

Last summer's two-week road trip from Ames to Seattle and back was well timed, with floods making Iowa a good place to be from--far from. In addition to the MARAC convention, my brother Don (W7NG) lives in Ballard (north Seattle--not far from the Red Hook brewery which gives a good tour). Here are the high and low points of the trip:

Was I embarrassed? In the hospitality room, I asked Joyce (WB9NUL) who she was travelling with when she offered contacts with WB0-DcIta-Papa-DcIta—who I had not met at the convention. I just thought they were two YLs with very similar voices, and I forgot all about the MARAC club station (which Joyce was running at the time). Come on, was I the only one so easily confused? Probably.

On the other side of the NUL equation is Barry, W9UCW. After attending his presentation on mobile antennas (my second in three years), I can safely say that the antenna theory which Barry spells out so clearly really is practical. I added one of his two-foot mast extensions, for a total of seven feet before the resonator (actually a 40% increase). Re-tuning in the parking lot of a Spokane motel didn't take long at all. But now the resonator sways back and forth way up there, since the base is already at the 4-foot level on the rear corner of my mini-van. More people come back to my first calls now so there is a definite improvement in signal radiation. Maybe I will add the 40 meter coil for the next Ohio trip so I won't have to stop and change, even though the antenna will be very top heavy.

Maybe the longer mast would have helped me be heard while driving west through Canada. Others at the convention said they had similar experience, with signals just not getting over the mountains (in Alberta and British Columbia) and county hunters not turning their antennas north (which would pick up Saskatchewan for a relay). But my log does contain a few contacts as /VE5, /VE6 and /VE7. Incidentally, I entered Canada with my original license and several copies, just in case, but the border guard was not the least bit interested. She was very concerned about the health certificate from the vet; maybe it was the barking dogs. . .

The graying of MARAC was noticeable at the banquet, with some emotional speeches referring to departed members and some who are seriously ill. We do need to publicize the net in more publications, maybe with presentations at local radio club meetings. A volunteer speaker would be welcomed by most program chairs. Another boost may come from the new, smaller HF rigs. Now if we can get people over their hesitancy to drill antenna mounting holes in their cars. Come on, people, you won't get much for a used car anyway.

My short distance award goes to N6OQZ, whom I spoke with in the parking lot of the Doubletree and again when he passed me on Interstate 90 in King County. I turned down my power and called him on 14.336 (sorry to interrupt the net, if it heard me with low power, but that is where I assumed he was listening) and we QSYd to have a bumper-to-bumper QSO on 14.325. Bud wanted to put out Kittitas County, the next one east, so he parked the vehicle and I went back up to the net to give the information. The trouble is, when Bud called QRZ, his signal was so strong it blocked out my receiver's front end and I could not tell if the net heard me or not. So I went back to his frequency to tell him to QRX a second and then back up to 336 to try again, successfully this time.

In central Washington we got off busy I-90 in Grant county and took parallel state route 28. When my turn on the net came up, I promptly worked WB9NUL (and DPD), K7IOO, and KC7IC, all also in Grant, Washington.

The good ears award goes to KZ2P, a frequent net control. He told me that my signal was distorting and to check my antenna connection. Impossible, I thought. But at the next stop, somewhere in Nebraska, I found a loose joint between the lower mast and the new extension. There now is a lock-washer between the two and I tighten anything threaded frequently (but not enough to strip the threads, yet).

I get to keep the bad ears award for another year. I had not brought a Wyoming map along since I did not see that US 212 passed through a small corner of that state. When I asked someone on the net to tell me the name of the county in the northeast corner of Wyoming, I thought they answered "Cook," and I replied, "Just like in Illinois?" They laughed in agreement, or so I thought. Later, I found out that the Wyoming county was named "Crook." Sorry, Chicago.

Question: how could I give Avon (WB7WBZ) a 4-4 but only a 3-3 to her OM (W7LQT), when they were operating mobile, on the same rig and antenna, for QSOs only seconds apart? Easy; she has a nicer voice.

Apologizes to WB2UJH who needed Big Horn for his last in Montana. I tried several times to convey an honest 5-7 report back to him without success. He must live in a highnoise area, or I'm not getting out as well as I thought. Another station needed Carbon, Montana as his last county. Had I seen in advance that Interstate 90 was just across the river, I could have gotten off for a few minutes. But, as the philosophical ones say, it will still be there.

My logger, Janet, was getting into the spirit of accumulating contacts. She also observed that operating or even just listening to the net increased the general level of alertness of driver and passenger alike, and contributes immeasurably to having a safe trip. However, even Janet got a little frustrated when I tried to cram in as many as possible from Dixon, Nebraska, with the sign for Dakota County already in view. I know, I could have stopped before the line, but we had just run Dixon off frequency and not too many moved down (as usual). It will still be there, too.

The sum from this trip was 608 contacts by AD0H operating in 70 counties, eight states, and three provinces. While I have no aspirations to put out all 3076, my total is up to 399 counties from 20 states, but who's counting?

### Members Speak!

N3DRO, Barb - I heard on the net that someone wrote an article about mobiles getting special privileges, I haven't had a chance to read the article but here's what I think. I've been on both ends so I do know what its like.

Do you really think they should? There are a few reasons I don't think they should! No. 1 - Is it right or fair for a person that never or very seldom runs counties to get the county or get relayed in to get the county just because they say they are mobile? What about the people that are sitting at a fixed station, who can only run 100 watts or less and an inside antenna or whatever they can rig up because they can't have outside antennas? I think that most mobile

installations are better than those! No. 2 - Most of the mobiles these days are running amplifiers and putting out a lot of power, is it really a LOW power mobile net anymore? If you have confidence in your installation, why get special privileges and if you don't and don't get the county, it will still be there, just like for the fixed stations. No. 3 - Why should I or anyone miss out on a county just because I'm not sitting outside in my driveway or doing errands just to be mobile! If you have listened to my operation you will hear that unless I'm on the list or it is a next to last or last, I don't say mobile unless I get thru, then I say I'm mobile and what county I'm in. Why can't and shouldn't it be run that way? If you are on the list and running counties, then I can see getting relayed, IF THE STATION IS WEAK, otherwise, do it yourself. Also, most mobiles can hear better in their mobiles than at home. I know I have asked! Now I know if the net was run this way, there would be people who would get on the list whether running counties or not, just to get the county. Think about this and make up your own mind, but think long and hard, from both points of view. I'll probably make some people angry over this (I hope not), but if that is the way its to be, then so be it! I've thought this way for a long time and I thought it was about time I expressed it. I'll continue to operate this way because I think it is the fair and best way! I would like to hear your opinion about this, AGREE OR NOT!

WA9QNI, Jack - I have recently corresponded with ACES (Amateur Confirmation Exchange Service) and informed them that I have decided that I will not continue to support this new service. One of my reasons for this decision is simply that, while you have every right to offer this additional service, I do not agree it is necessary or even helpful. It might even be harmful as it could result in County Hunters being without any confirmation service if the "Bureau" decides it can no longer afford to continue what has been an unprofitable and steadily decreasing volume and then you should decide later that you are unable or unwilling to put in the time necessary to continue any resulting increase in volume. Another reason, I do not really enjoy checking and verifying MRC's, especially any large group of cards. I can handle one large bunch from a single source on a once a month basis but I just don't care to receive other bunches from your service nor from others that might decide to follow your move. I consider the service of the existing bureau at least adequate. Compared to such services available to other groups, it is far superior Hope you understand my position and should your service become the only such service available to county hunters, then I would be happy to support it just as I now choose to support the established Bureau.

Suggest phone activity on the even hours; 15/10 meters on the odd hours [1500 to 2100 UTC]; 160 meters at 0500 UTC. [4] Exchange consists of QSO Number, RST, and QTH [State/province or country]. New Jersey stations will send county for their QTH. [5] Scoring: Out-of-state stations multiply number of complete contacts with New Jersey stations times 3 points per QSO times the number of New Jersey counties worked [maximum of 211. New Jersey stations multiply number of complete contacts times 3 points per QSO times the multiplier. The multiplier is the sum of the number of states [other than NJ], provinces, and NJ counties worked - maximum is 49 + 12 + 21 = 82. [6] Certificates will be awarded to the first place station in each New Jersey county, state/province, and country. In addition, a second place certificate will be awarded when four or more logs are received. Novice, Technician, and mobile operator certificates will also be given. #### How ACES Works ......

ACES does not batch MRCs once-amonth for shipment to mobiles and returns to fixed stations. All MRCs and first contact QSLs are sorted daily, and when at least an envelope full (one - two ounces) is in hand, the cards are mailed.

The computer is used extensively at ACES. Incoming and outgoing mail is logged so that we know what has happened, and when. When an MRC is received for the first time for a station, the call and date are logged. If 28 days pass without a mailing to that station, the computer alerts us, and a mailing is prepared.

Just as mail is received daily with new cards to process and returns from mobile stations, signed cards are mailed back to their originators, daily.

### Please Write Legibly.....

As MRCs and QSLs are processed as received, and with hundreds of cards being handled, PLEASE take the time to write the call signs (both the FROM ARS and TO ARS) legibly. If we cannot easily read your writing, the cards are put aside until later. Sometimes it

takes a "committee meeting" to determine to whom a card is going. The computer generated cards are wonderful, as are those neatly hand printed. Please help us help you.

### How Long Should Logs Be Saved .....

I've noticed MRCs with contacts that date back many years. Most often, the mobile station will find the old log, clear off the dust, and confirm the contact.

Occasionally, the MRC is returned with a comment that "logs are only kept for X years, SORRY." While the decision on how long to keep a logbook is solely that of the mobile operator, if it is important to get the contact confirmed, it is important to do it quickly.

The longer the time between contact and submission of MRC, the smaller the chance of receiving confirmation.

#### Information On ACES.....

For information on ACES, just drop a note in the mail. Hope to see many of you in Springfield.
